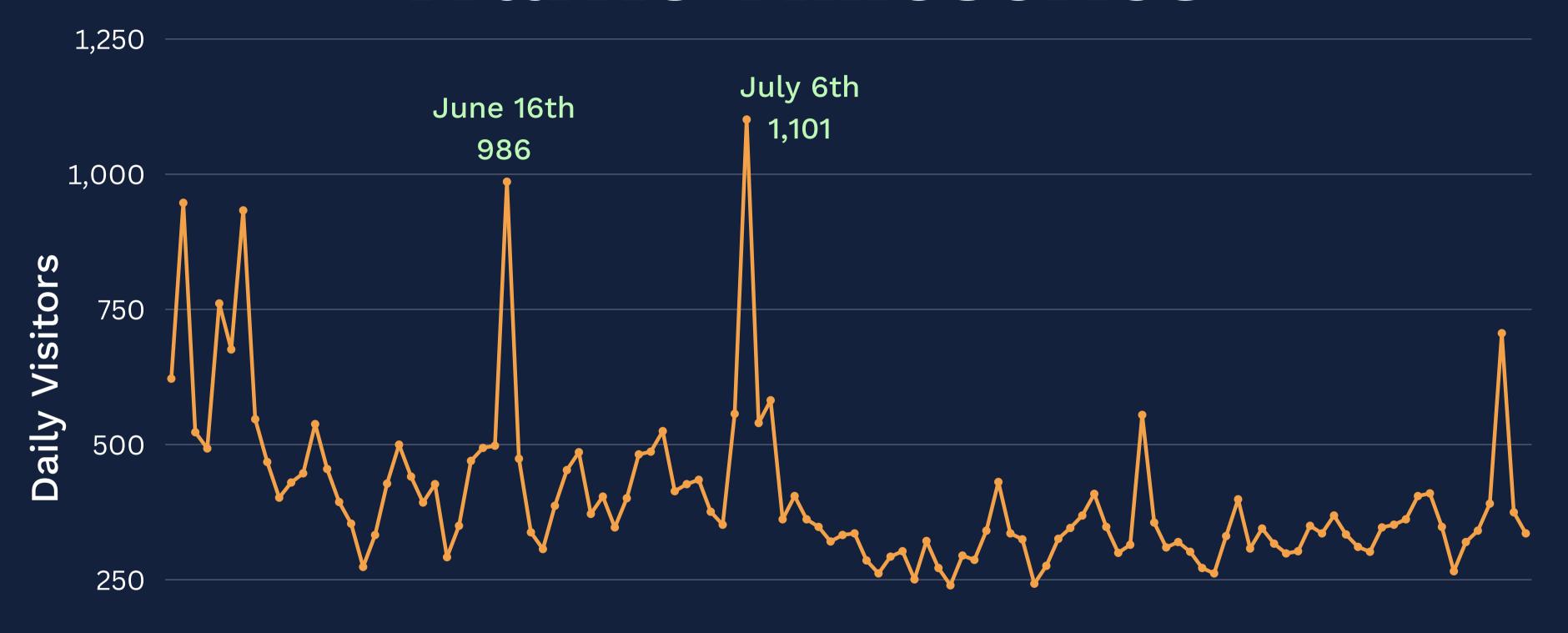

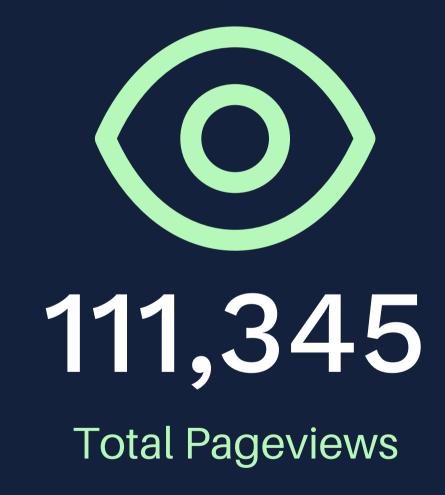


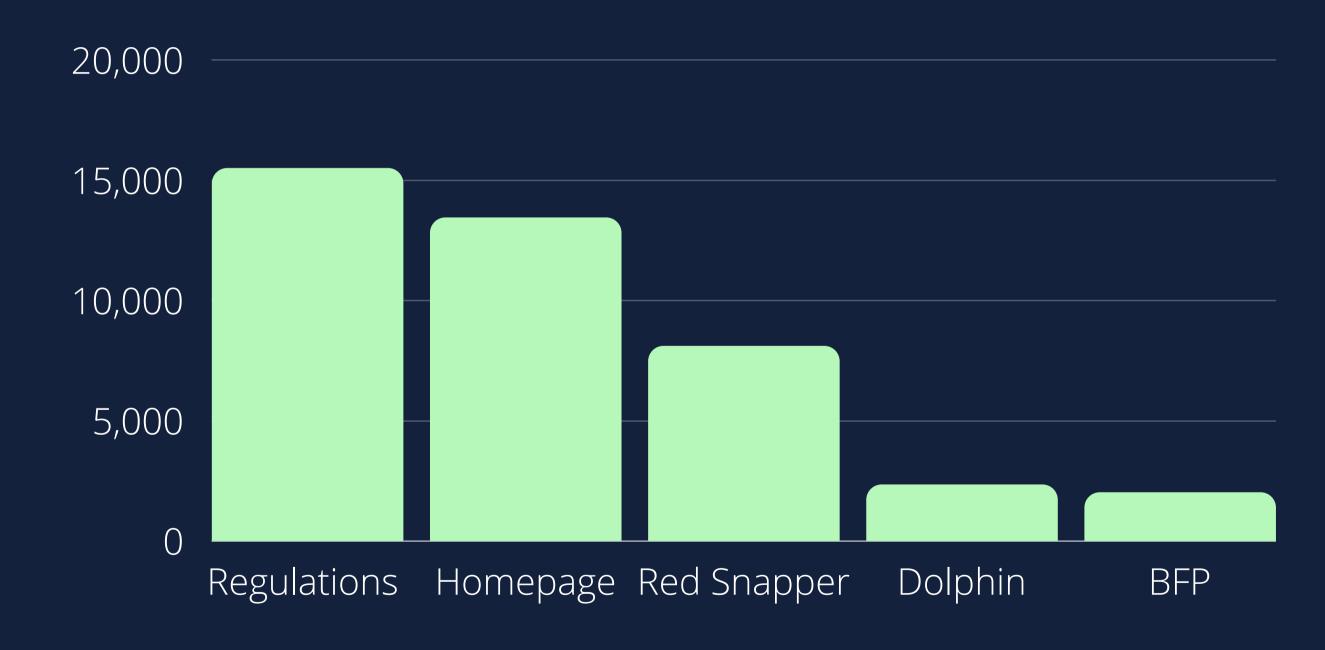
Traffic Timeseries





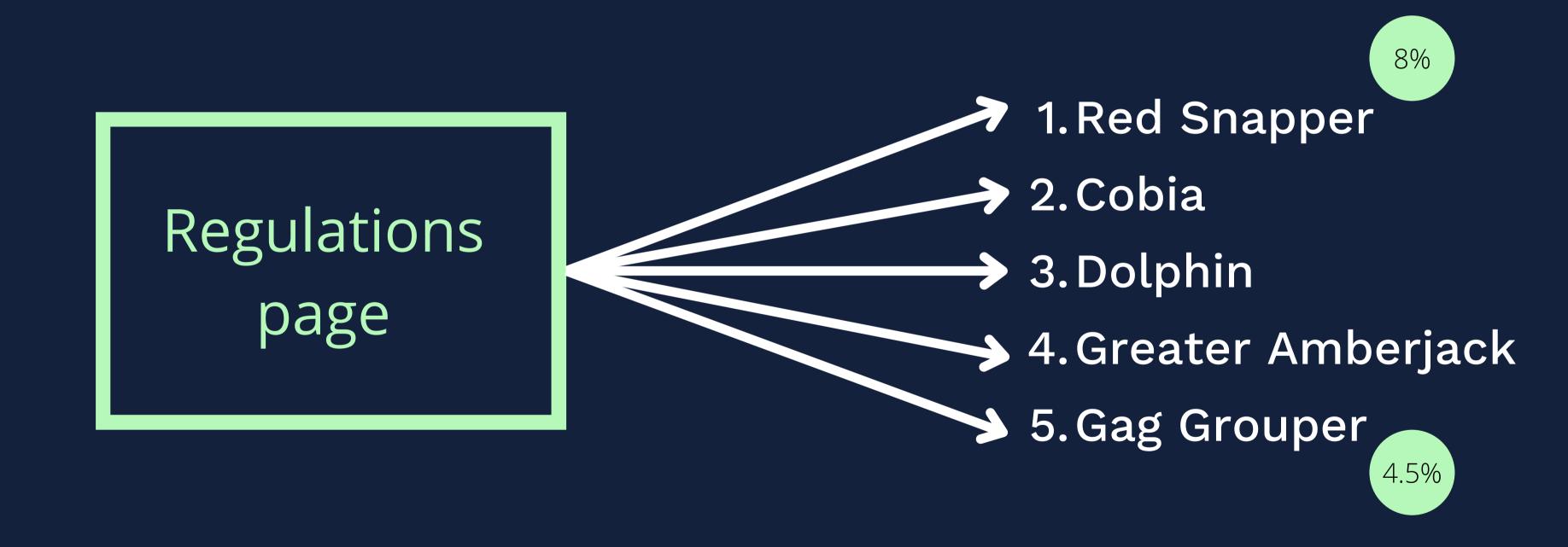

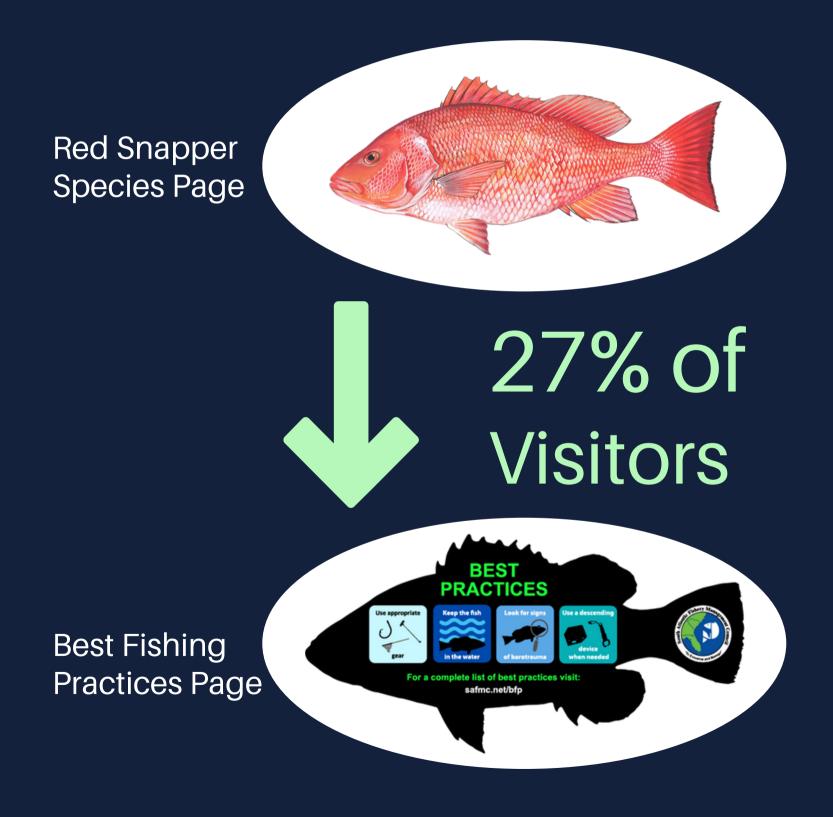
Pageview flow
