



THE SOUTH ATLANTIC FISHERY MANAGEMENT COUNCIL Update on modification to commercial coastal logbook program



### Background

- The commercial coastal logbook program collects data from commercial vessels in the Gulf of Mexico and throughout the Atlantic
- In the South Atlantic, commercial fishermen holding Snapper Grouper, Dolphin Wahoo, or Coastal Migratory Pelagic permits are required to fill out a paper logbook within 7 days of completing a trip and mail it to the SEFSC
- A subset (20%) of commercial coastal logbook participants are selected to also fill out an economic or discard survey for a year
  - Mailed out separately from coastal logbook
  - Mandatory to complete if selected



### Background

This amendment would modify the FMPs for:

- South Atlantic Snapper Grouper,
- Atlantic Dolphin Wahoo,
- Atlantic and Gulf of Mexico Coastal Migratory Pelagics,
- Gulf Reef Fish

to require commercial logbooks be submitted via electronic reporting forms instead of the currently used paper-based forms.

## Benefits of electronic logbook

- Accommodates vessels with multiple permits (one-stop reporting)
- Better compliance and timeliness for permit renewal
- More accurate information



### What will change?

Commercial logbook data fields have already been integrated into eTRIPS to be compatible with Atlantic standards through the Atlantic Coastal Cooperative Statistics Program (ACCSP)

- See Spreadsheet
- The data will then be made available to NMFS from ACCSP
- Timing for reporting will be unchanged (7 days)

### Voluntary (unless selected by NMFS) portions of the commercial electronic program (economic and discard surveys)

- The economic survey will have some additional data fields to be compatible with ACCSP's database
- Discards will be reported when completing the commercial logbook
- These two surveys will remain voluntary unless selected

# Why are there more data fields in the electronic logbook?



- To streamline data collection across federal and state agencies
- To accommodate vessels with multiple permits so the correct information is collected
- In general, the additional fields either collect the same information, but in a different way than on paper (gutted vs whole weight) or ask for a better estimate of the trip duration or characteristic (end/start port or trip end time).
- Changing existing data fields would require the ACCSP committee agreeing to changes.
