Update on modification to commercial coastal logbook

program



### **Purpose and Need**

The **purpose** is to modify reporting for commercial fishing vessels issued South Atlantic or Gulf of Mexico permits and currently reporting through the Southeast Coastal Logbook program (Gulf Reef Fish, South Atlantic Snapper Grouper, Atlantic Dolphin and Wahoo, and Coastal Migratory Pelagic Resources of the Gulf and Atlantic), to require that the reports be submitted electronically.

The **need** is to improve the timeliness and efficiency of the commercial logbook data collection and management program, which will improve monitoring and compliance of federally permitted commercial vessels participating in the Southeast Coastal Logbook program.



# Progress since September meeting

- Outline of document and Chapter 1 of joint amendment (Attachment 2a) drafted.
- Proposed revisions to development timeline.
- Advisory Panel meetings held this fall:
  - SA Mackerel Cobia (October 5-6)
  - Gulf of Mexico Reef Fish (October 11)
  - SA Snapper Grouper (October 18-20)
  - Gulf CMP AP (December 1)
- Work begun on Chapter 2 (RIR) to assemble info for effects analysis

April 2023 Gulf Council approves for PH

PH in spring SA, Gulf, (and Mid Atlantic)?

June 2023 SA Council approves for formal review

June 2023 Gulf Council approves for formal review

Late 2023 Final rule published

Early 2024 Regulations effective



## **Summary of APs' input**

 APs generally supportive of proposed change. Willingness to test currently available application (eTRIPS).

- Some skepticism about whether electronic submissions would improve permit renewal process
- Questions about potential of improved compliance with 7-day timeline for submission and discrepancy in timeline between SE and GARFO



# Summary of APs' input (cont'd)

- Questions about building in time of overlap for paper and esubmissions following implementation
- Questions about revising timeline of submission for economic add on survey for selected vessels to minimize delay in payment
- Questions about how e-reporting requirements would affect owners of multiple permits under separate corporations and leasing of permits (SG1)

 Obtain input from Gulf Coastal Migratory Pelagics AP and Dolphin Wahoo AP

 Economic description for the 4 FMPs will be completed in early 2023

 Preliminary effects analysis will be available for SA and Gulf Councils to approve for PHs in March and April, respectively.
