Snapper Grouper Management Strategy Evaluation

Staff Lead: Chip Collier, Judd Curtis

Purpose of the Amendment: Dead releases are a major issue in the snapper grouper fishery as a whole and affect many species within the complex. The Council has directed a management strategy evaluation (MSE) project that would consider multispecies effects of potential management changes and be used to develop a more holistic approach to management of the snapper grouper fishery. The amendment will follow the MSE project and consider implementation of management changes evaluated through the MSE.

Action Summary: This amendment will provide actions intended to incorporate recommendations from the MSE project.

Spawning Special management Zones - Regulatory Amendment 39

Staff Lead: Allie Iberle

Purpose of the Amendment: Evaluate sunseting of Spawning Special Management Zones (SSMZs). To support the evaluation of the SSMZs and other protected areas, the Council established the System Management Plan (SMP) Workgroup. The workgroup is in the process of finalizing an evaluation and conducting the review. Their report will be provided to the Council to consider extending regulations for the SSMZs or allowing the regulations to sunset.

Action Summary: The Council approved a motion to initiate a framework amendment to remove or extend the sunset provision for the SSMZs.

Standardized Bycatch Reduction Methodology 5-year Review

Staff Leads: Council Staff, SERO, SEFSC

Purpose: Standard Bycatch Reporting Methodology (SBRM) are required for every federal fishery management plan. A final rule requiring review of SBRM's every 5 years was published in February 2017. The first review of the SAFMC's SBRMs was conducted by NMFS with help from SAFMC staff. The SSC will be asked to comment on the methodology and design considerations such as data elements, sampling designs, sample sizes, and reporting frequency. The SSC will discuss the review of the methodologies used to describe bycatch reporting and data gaps present.

Joint Commercial Logbook Amendment

Staff lead: Myra Brouwer

Purpose of Amendment: To allow submittal of electronic commercial logbooks.

Action Summary: This amendment is being developed jointly with the Gulf of Mexico Fishery Management Council. The amendment modifies the FMPs for South Atlantic Snapper Grouper, Atlantic Dolphin Wahoo, Atlantic and Gulf of Mexico Coastal Migratory Pelagics, and Gulf Reef Fish to require commercial logbooks be submitted via electronic reporting forms instead of the currently used paper-based forms.

Most recent document: Final Amendment in Administrative Record.

Development level: Under review. Amendment submitted on February 27, 2024.

Key Events: refer to December 2023 Active Amendments Document.

Coral Amendment 11/Shrimp Amendment 12 (CHAPC Modifications and Shrimp Fishery Access Area)

Staff Lead: Kathleen Howington & Allie Iberle

Purpose of the Amendment: To establish a Shrimp Fishery Access Area (SFAA) along the western boundary of the northern extension of the Oculina Bank Habitat Area of Particular Concern (OHAPC) where fishing for rock shrimp would be allowed. The area under consideration was once utilized by the fishery but access to it was restricted with implementation of Coral Amendment 8 in 2014.

Action Summary: to establish an area within the existing OHAPC where rock shrimp fishing would be allowed to restore access to historic grounds to the fishery while maintaining protection for Oculina coral.

Purpose of Amendment: Respond to the latest stock assessment (SEDAR 68).

Action Summary: Establish a scamp/yellowmouth grouper complex, remove yellowmouth grouper from the shallow water grouper (SWG) complex, establish catch levels and sector allocations for the new complex, adjust catch levels and sector allocations for the SWG complex.

Amendment 48 (Wreckfish ITQ Program Modernization)

Purpose of Amendment: The Council finished its second review of the Wreckfish ITQ program in September of 2019. As part of the review there were several recommendations made to modernize the program, which will be addressed in this amendment.

Action Summary: moving away from a paper coupon-based program to an electronic program; fishing season; cost recovery; wreckfish permit requirement; allocation issues; offloading sites and times; and monitoring requirements.

Snapper Grouper Regulatory Amendment 36 (Gag and Black Grouper; On-Demand Gear)

Purpose of Amendment: Revise recreational vessel limits for gag and black grouper and specify requirements for on-demand black sea bass pots while transiting through closed areas

Action Summary: Revise the recreational vessel limits for gag and black grouper to be an aggregate bag limit including both species. Revise transit requirements for on-demand black sea bass pots.

Most recent document: Final amendment in Administrative Record.

Development Level: Under Review. Amendment submitted to NMFS on March 31, 2025.

Regulatory Amendment 37 (Black Sea Bass Management Measures)

Purpose of the Amendment: Address depleted status of black sea bass in the South Atlantic immediately with management measures aimed at reducing regulatory discards and protecting the spawning stock.

Action Summary: establish recreational and commercial annual catch targets and revise accountability measures, reduce the recreational bag limit, and implementing an annual spawning season closure in February and March for both commercial and recreational sectors.

Most recent document: December 2025 Decision Document & Draft amendment

Development level: Approved for submission

Key Events:

Under Development:

Snapper Grouper Amendment 44/ Reef Fish Amendment 55 (Yellowtail & Mutton Snapper)

Staff Lead: Allie Iberle

Purpose of Amendment: Respond to the latest stock assessments for yellowtail snapper and mutton snapper (SEDAR 96 and SEDAR 79, respectively). Neither species is overfished nor undergoing overfishing.

Action Summary: Adopt recommended stock OFL and ABCs, adjust the jurisdictional apportionment between the South Atlantic and Gulf Councils, update regional ACLs, and update South Atlantic sector allocations.

Most recent document: March 2026 Decision Document

Development Level: Pre-public hearings

Key Events:

- February 2025: Sub-groups of South Atlantic and Gulf SSCs reviewed the amendments and recommended ABC for each species.

Purpose of the Amendment: Evaluate whether 14 species currently in the FMU should remain, be removed, or be designated as ecosystem component species. Note: this amendment supersedes an earlier proposed amendment to specify ABCs for unassessed snapper grouper species.

Action Summary: To determine the need for conservation and management of 14 snapper grouper species.

Most recent document: March 2026 Decision Document

Development level: Post-scoping

Key Events:

- March 2025: Council initiated work on the amendment.

Amendment 60 (Commercial management measures)

Purpose of the Amendment: The amendment has two main objectives: 1) address issues related to the commercial Snapper Grouper Unlimited (SG 1) permit, and 2) increase commercial trip efficiency.

Action Summary: Revise the 2-for-1 snapper grouper commercial unlimited permit policy; establish dynamic (step-down) trip limits; and revise existing stowage requirements for gear on board.

Key Events:

- December 2024: Amendment development initiated.
- March 2025: amendment development paused pending resolution of commercial landings discrepancy between the assessment and ACL monitoring.

Evaluation for the Need of Continued Management for 9 Snapper Grouper Species

Purpose of the Amendment: In October 2019, the SSC recommended designation of Cubera Snapper, Margate, Silk Snapper, Coney, Saucereye Porgy, Yellowfin Grouper, Misty Grouper, Blackfin Snapper, and Yellowedge Grouper as ecosystem component (EC species).

Action Summary: To determine the need for conservation and management of 9 snapper grouper species.

Most recent document: None

Pelagic Longlines in the Dolphin Wahoo Fishery

Purpose of the Amendment: This amendment would consider implementing changes to the commercial longline fishery for dolphin and wahoo to better align with HMS requirements and potentially respond to recommendations from the forthcoming updated Biological Opinion for the dolphin wahoo fishery.

Other Work Items

South Atlantic Ecopath with Ecosim Model Application

Staff Lead: Chip Collier

The SSC reviewed the SAFMC EwE model development in October 2020 and recommended that the model was ready for applying to specific questions of interest to the Council. In December 2020, the Council identified 4 potential questions to address with the model. Staff is working with FL FWC staff to provide a contract to support FWC leading the effort to apply the model to 2 of the Councils questions. The impact of high Red Snapper recruitment was reviewed by the SSC in October 2021 and presented to the Council in December 2021. The second product will be the development of a model of intermediate complexity for ecosystem analysis (MICE). The MICE model was completed in June 2022 and a preliminary model was developed. A new contract was developed in 2023 to add Ecospace

module into the Ecopath model to describe potential shifts in species distribution. The pilot species is Black Sea Bass. The project was presented to the SSC in April 2025.

Wreckfish ITQ review

Staff Lead: Christina Curtis, John Hadley, Myra Brouwer, Chip Collier

Staff proposed a workplan to accomplish the review, which is due to be completed by late 2026:

- March 2026: Contractor is selected to collaborate with Council staff
- March 2026: Data request sent to NMFS with a deadline of June 2026.
- June 2026: Council reviews outline for the review
- Summer 2026; Councils staff and contractors complete the draft review
- September 2026: wreckfish AP reviews the draft and provides recommendations
- December 2026: Council reviews comments from AP, makes any updates to the draft, and finalizes the document.

Framework Amendments

- The approximate time frame from when Council submits a framework amendment to NMFS and the implementation date is 6-9 months.
- NMFS does not publish an NOA for a framework amendment.
- The public comment period for proposed rules is usually 30 days.

- Plan Amendments

- The approximate time frame from when Council submits a plan amendment to NMFS and the implementation date is 9-11 months.
- NMFS publishes an NOA for a plan amendment, followed by the proposed rule.
- The public comment period for proposed rules and amendments (NOA) are usually 30 and 60 days, respectively.
