- BOEM Marine Minerals Program (Joint Consulting Agency)


#### 13 Years to Complete!

- 1997 SARBO

   Amended 1995 opinion
- 2007: USACE formally reinitiate consultation
- 2008: USACE/ BOEM Joint SARBA
- 2018: Meet with State Partners
- March 27, 2020: SARBO Signed by NMFS
- July 31, 2020: SARBO revised to clarify use of single-beam sonar

### More Activities Covered

### Five types of activities covered under the 2020 SARBO

#### 1. Dredging

- Maintenance dredging
- Dredging/sand mining in borrow sites
- Restoration dredging/muck dredging to improve water quality

#### 2. Dredge material placement

- Sand placement for beach nourishment
- Nearshore placement
- Placement in an Ocean dredged material disposal site (ODMDS)
- Upland placement

3. **Transportation of dredge materials** between dredging and material placement locations.


4. Geophysical and geotechnical surveys performed by or authorized by the USACE necessary to complete dredging and material placement projects

# 5. Monitoring for and handling of ESA-listed species encountered

- Relocation Trawling
- Genetic Sampling

#### **2020 SARBO Action Area:**

- ■Waters off of the Atlantic coast, from the North Carolina/Virginia border south to the tip of Florida including the Florida Keys
- ■Waters off of the Islands of Puerto Rico and the U.S. Virgin Islands.
- Sturgeon spawning rivers

- Effects from tagging, genetic sampling

#### 4. Vessel Strikes



- 5. Species Interaction with Material Placement
- 6. Blocked Access by Construction or Material Placement
- 7. Habitat Alteration
- 8. Sound Generated by Projects
  - Equipment noise
  - Geophysical Surveys



# Other Major Changes in 2020 SARBO USACE/ BOEM/ NMFS Partnership

- Frequent coordination to determine if/when changes are needed
- Increased reporting including annual review of project specific details and lessons learned

### Project Design Criteria (PDCs) and Risk-based adaptive management

- All projects must meet PDCs. Determined under umbrella of risk-based assessments
- Internal living document considering risk to all species and habitat and recommending minimization measures at a project and regional scale

### **Species-Specific PDCs**

North Atlantic Right Whale Conservation Plan, ESA-listed Corals, Atlantic sturgeon

### Supersede procedures- Avoids unnecessary consultations and reinitiation

- Covers actions with effects that are substantially similar to the effects considered in the Opinion
- Covers unplanned actions, equipment, etc.

# Additional Ongoing Research

- USACE Water quality changes around dredging
  - ERDC tested in Savannah, Charleston, and Wilmington
- USACE Hydrodynamic modeling of specific areas
  - Port Everglades, Wilmington, Morehead City
- BOEM Sea turtle and Giant Manta behavior studies and **Relocation Trawling efficacy study**
- Innovative ways to reduce take on hopper dredging
  - Tickler chains, lighting, water-injection
