Black Sea Bass is undergoing slight overfishing Stock is not overfished: MSST < Stock Biomass < SSB_{MSY}


AMENDMENT 18A:

NORTH ATLANTIC RIGHT WHALE

• Highly endangered (<400 in population)

- Potentially vulnerable to entanglement in pot gear
- Multiple migrations from NC to NE FL between Nov-Apr

WILL 18A IMPACT RIGHT WHALES?

Black sea bass stock is rebuilding \rightarrow ACL may increase

Amendment 18A management measures should reduce effort and could extend the length of the commercial fishing season.



Will new management measures extend the commercial fishing season into right whale season (November-April)?




FORECASTING METHODS

- >10 methods evaluated for projecting season length
- Seasonal Auto-Regressive Integrated Moving Average (SARIMA) model provided best fit to data and had low retrospective bias for 2011/12 catch estimates.
- SARIMA predicted monthly black sea bass pot catch per day using a linear combination of historical logbook catch data (accounting for seasonal trends) and past, present, and future exploitable abundance.



PREDICTOR VARIABLE: POT-EXPLOITABLE ABUNDANCE







FORECASTING METHODS

- Projections excluded permit holders not meeting endorsement lb qualifier.
- Historical harvest constrained to trip limit if landings previously exceeded trip limit.
- Model fit accounts for missing landings due to quota closures.
- Non-pot gear landings were projected as a percentage of pot gear landings using the most recent 3-year average of months when the commercial sector was open.

RESULTS: SARIMA MODEL FIT

Notes: ACLs from constant F rebuilding projections given 50% overage in 2011-2012 landings (SEDAR 25 2011).



Forecasts based on preferred alternatives in Amendment 18A indicate closure likely in Aug (UCL: July; LCL: Nov)


Under the current suite of preferred alternatives in Amendment 18A, it appears legal black sea bass pot gear will pose no risk to North Atlantic right whales through May 2014.


