- The tables show monthly landings since the 2008/09 fishing year. Cumulative landings are shown until the 2012/2013 fishing year. These are landings through November 5, 2013.
- King mackerel landings are lower through October (973,189 lbs) than they were at same time last year (1,291,352 lbs).
  - Landings in the 2012/2013 fishing year were lower than any previous year since 2008/09. 45% of the commercial quota was met last year.
- For Spanish mackerel, landings through October of this year (1,477,679 lbs) are almost 128,000 lbs less than they were at this time last year (1,605,717 lbs).
- The quota was exceeded by 4% last year.
- For cobia, landings are slightly higher than they were at this time last year. Overall, 100% of the quota was met last year, but it does not appear that we will need to close cobia this year.
