SEDAR Steering Committee May 2, 2011 Charleston, SC

DRAFT Meeting Summary

1. Introduction and Opening Remarks

The Committee approved summaries from the October 2010 and March 2011 meetings.

2. Activities Update

SEDAR 27 Benchmark (yellowtail snapper and Gulf of Mexico Menhaden): The Committee agreed that the Gulf and South Atlantic Council should each appoint 2 SSC members to serve as reviewers on the Review Workshop Panel, and that the Gulf Council will appoint a chair from its SSC.

DWH Workshop: The committee recommended that individuals experienced with oil spill, such as the Exxon Valdez, be invited to participate in the DWH workshop. In particular, they should be asked to relay lessons learned, especially with regard to data collection in the early stages.

3. SEDAR Guidelines and Policy Documentation

The Committee approved the revised SEDAR guidelines. Specific changes made during discussion include the following:

- eliminate the Steering Committee vice-Chair position.
- travel support and salaries for Council members attending SEDAR workshops will be provided by the appointing Council.
- Council shall appoint 2 SSC representatives to SEDAR benchmark review panels. For stocks managed by multiple Councils, each Council with a management interest shall appoint 2 SSC representatives.
- Clarified that SSCs should recommend to the Council whether assessments represent Best Scientific Information Available.
- Discussed adding SSC chairs to the Steering Committee, and decided instead to create a SEDAR Technical Committee (see addendum 1) to obtain feedback on scheduling, workload, and procedures.
- 4. Revised Terms of Reference













Committee members are asked to provide comment on the draft TOR revisions by June 20. This issue will be addressed in detail at the next meeting.

5. SEDAR Schedule and Workload Planning

The Committee reviewed 2012 assessment projects and discussed methods of increasing feedback to the committee from SSCs and agency scientists. The final 2011-2012 work plan, and proposed assessment priorities for 2013-2015, is provided in Table 1.

Schedule revisions for 2012 include:

- Eliminated the king mackerel benchmark. King mackerel will be considered in a future update, timing is not set at this time. This will allow ageing effort to be directed toward Spanish mackerel and cobia, as both the Gulf and South Atlantic Councils indicated these stocks are higher priorities than King. King has been assessed several times through SEDAR and is neither overfished nor overfishing.
- A benchmark project cycle will be devoted to Gulf and South Atlantic Spanish Mackerel and Cobia. This project will likely start in mid-2012 and should include data through 2011.
- South Atlantic white grunt will be benchmark assessed in 2012. The SAFMC request to replace white grunt with gray trigger was rejected, based on the inability to complete life history work for this stock in the time allotted. This project will likely begin in Summer 2012 to include data through 2011.
- South Atlantic vermilion snapper and red porgy, update assessment, including data through 2011 and provided to the SAFMC SSC in late October 2012.
- Gulf of Mexico red snapper, as a standard assessment, using data through 2011.
- Caribbean blue tang, white grunt, and queen trigger benchmark assessments.
- Florida FWCC, mutton snapper standard assessment, tentative and dependent upon FL FWCC activities.

Increasing schedule feedback.

The Committee recognizes the need to increase feedback on assessment priorities and scheduling from SSCs and agency scientists. The SEDAR Technical Committee (addendum 1) will be convened electronically, prior to the next Steering Committee meeting, to review stocks proposed for assessment in 2013 and beyond. The committee will consider analytical and life history needs in recommending which stocks can be assessed for 2013, what type of assessment should be pursued, and how projects should be scheduled during the year to optimize productivity and data timeliness. The Steering Committee will review these recommendations at its next meeting, expected in October 2011, and finalize the 2013 work plan. No further changes in the assessment work plan for 2013 will be considered following this action.

6. SEDAR Website Design Proposal

Committee members are asked to review the website proposal powerpoint and submit comments to SEDAR staff by July 1. This issue will be addressed at the next meeting.

7. Summary Report Revision

This issue will be addressed at the next meeting.

8. Budget Report

Bob Mahood briefed the Committee on the budget. The 2011 budget is delayed due to delays with the overall federal budget.
