

# 2.2.1. Yellowtail Snapper Review

Stocks: Southeast Yellowtail snapper

**Coordinator:** Julie A. Neer

**Progress Summary: Completed:** The CIE review of the yellowtail snapper has been concluded. The assessment was reviewed by the Gulf and South Atlantic SSCs in October 2012.

# 2.3.1. SEDAR 28 Benchmark

Stocks: Gulf and South Atlantic Spanish mackerel and cobia

Coordinator: Ryan Rindone

**Progress Summary:** Atlantic stocks assessments are completed and will be reviewed by the SAFMC SSC in April 2013. A desk review of the Gulf stocks assessments is in progress, with review by the Gulf SSC in March 2013.

# 2.3.2. SEDAR 30 Benchmark

**Stocks:** Caribbean blue tang and queen triggerfish

**Coordinator:** Julie Neer

**Progress Summary: Underway.** Data scoping was conducted in July and the AW in October. A desk review is underway. CIE reviewers are expected to be received mid-March.

# 3. SEDAR Assessment Schedule

# 3.1. **Documents**

#### 3.2. Overview

The Steering Committee left a few scheduling items for 2013 open following its last meeting in October 2012. Additional action was required by the Gulf and Caribbean Councils before finalizing the SEDAR project schedule. In addition, two issues were raised during the October SAFMC SSC meeting and December SAFMC meeting that are offered for consideration. Specific items to consider are detailed in the following sections. Current projects with potential changes highlighted are summarized in Table 1.

#### 3.3. **ACTIONS**

# A. Gulf of Mexico 2014: Data poor stocks or benchmarks?

Two assessment slots for the Gulf were left undecided at the last meeting, with the choices being (1) assess several data poor stocks, or (2) assess 2 of scamp, gray trigger, or red snapper. The Gulf Council intended to discuss this topic at their next meeting and develop recommendations for consideration by the Steering Committee. The Gulf Council will discuss the 2014 SEDAR assessment schedule under "Other Business" at their February 2013 meeting in Mobile, AL.

The Gulf Council is asked to report to the Steering Committee on this issue for consideration and resolution.

# **ACTION: Approve 2014 Gulf assessment projects**

If the data poor option is chosen, several follow-up questions will need to be addressed.

- 1) Stocks to assess
- 2) Expected outputs
- 3) General approach, including workshops to hold and type of review

# B. Caribbean benchmark stocks in 2013

The committee supported the Caribbean Council's request to consider conducting a benchmark of red hind in 2013 if feasible given the Bi-op on parrotfish. The Caribbean Council is asked to report back to the Steering Committee on this issue so the Committee can finalize the schedule for 2013.

# **ACTION: Approve 2013 Caribbean assessment projects**

# C. South Atlantic Wreckfish

There is a lawsuit associated with this topic.

A wreckfish assessment is tentatively scheduled for 2016.

Two exploratory assessments of wreckfish were submitted to the SAFMC SSC for consideration in October 2012. These assessments were conducted outside of the Council and SEDAR process. The SSC recommended that a process similar to the SEDAR standard assessment approach could be used to refine and review these assessments, and that guidelines should be developed for handling outside or unsolicited assessments. The South Atlantic Council was provided the SSC recommendations in December 2013, and is awaiting the recommendations of the SSC on a process for addressing outside assessments. A report from the SSC is expected at the June Council meeting.

No specific action is required on this topic.

# **ACTION: Provide guidance as necessary**

# D. Procedures Workshop: South Atlantic Shrimp Data

The SAFMC SSC requested that a SEDAR procedures workshop be convened to review and evaluate data availability from the South Atlantic shrimp fishery. The objective is to explore datasets for bycatch, for use in finfish assessments, and directed shrimp fisheries, for use in future shrimp assessments. The SSC supports pursuing quantitative assessments of South Atlantic shrimp if data are available. This workshop is proposed as the first step in determining if the necessary data are available.

# Action: Approve Procedures Workshop V: South Atlantic shrimp data evaluation

# Outcome

- 1) Chairman Ponwith expressed concerns that future budget reductions may impact assessment productivity. Additional concerns were raised regarding the number of stocks proposed for consideration in 2014, especially since several addressed in 2013 and 2014 are known to require extra effort, such as red snapper and king mackerel.
- 2) The Committee declined to pursue the data poor stocks workshop for the Gulf of Mexico in 2014. Due to workload concerns raised by the SEFSC, the Committee agreed to move the assessment of Gulf gray triggerfish to 2015, to be conducted after red snapper is complete. Stocks to assess for the Gulf of Mexico in 2014 include king mackerel, red snapper, and red grouper.
- 3) The Committee supported benchmark assessments of Caribbean red hind and white grunt in 2013, and queen conch and spiny lobster in 2014.
- 4) The Committee supported convening a South Atlantic shrimp data workshop as a first step in pursuing stock assessments of South Atlantic shrimp. The workshop should be held in late 2014 or in 2015, if feasible given future budgets. Due to workload concerns, the Committee identified South Atlantic greater amberjack as a stock to potentially delay.

NOTE: Greater amberjack was dropped from the 2014 schedule in March 2013, following this meeting, per SEFSC insistence, during planning for 2014 projects.
