The Allocation Committee needs to: (A) receive a presentation from Julie Defilippi, Data Coordinator, on the ACCSP; (B) review the April 2008 committee meeting report and discuss/take action as necessary; (C) review status of staff requests for data/analyses and discuss/take action as necessary; and (D) review items to be discussed at the July 2008 committee meeting.

### Atlantic Coastal Cooperative Statistics Program (ACCSP) (Attachment 1)

Julie Defilippi, Data Coordinator, will give an overview of the ACCSP program with specific emphasis on the southeast and will also update the committee on the ability of ACCSP to provide data for analyses to be included in the Comprehensive Allocation Amendment.

#### **April 2008 Committee Report (Attachment 2)** В.

The written comment period ended on February 22, 2008. The scoping meeting minutes and all comments received were discussed by the committee during their April 2008 meeting.

Major recommendations from the committee are shown below. **REQUIRED COMMITTEE ACTION:** Discuss the Committee's April 2008 recommendations modify if necessary prior to presentation to the Council in June 2008.

1. Alternatives. The committee combined old Alternatives 3 (Council's Judgment) and 4 (Detailed Economic and Social Models – when available) and moved immediate consideration of old Alternative 4 (Detailed Economic and Social Models) to Appendix A (Alternatives considered but eliminated from detailed study.). The revised list of alternatives is as follows:

Alternative 1. No Action.

Alterantive 2. Landings Data from NMFS or ACCSP (Atlantic Coast Cooperative Statistics Program; <u>www.accsp.org</u>) Databases.

Alternative 3. Catch Data from Assessments (including discard mortality).

Alternative 4 (Preferred). Council's judgment based on fairness and equity – this approach would consider any number of factors including but not limited to social and economic values (including demographic shifts) and models, when available; landings data; and the Council's view of what fisheries should look like into the future.

The Committee will discuss these alternatives and present the following motions to the Council for approval to provide staff guidance on the alternatives to be developed in the Comprehensive Allocation Amendment:

**MOTION #4:** AMEND ALTERNATIVE 3 TO READ: COUNCIL'S JUDGMENT BASED ON FAIRNESS AND EQUITY – THIS APPROACH WOULD CONSIDER ANY NUMBER OF FACTORS INCLUDING BUT NOT LIMITED TO SOCIAL AND ECONOMIC VALUES (INCLUDING DEMOGRAPHIC SHIFTS) AND MODELS, WHEN AVAILABLE; LANDINGS DATA; AND THE COUNCIL'S VIEW OF WHAT FISHERIES SHOULD LOOK LIKE INTO THE FUTURE. ALSO, MOVE ALTERNATIVE 4 TO APPENDIX A. APPROVED BY COMMITTEE

**MOTION #5:** RECOMMEND TO THE COUNCIL THAT ALTERNATIVE 3 (COUNCIL'S JUDGMENT BASED ON FAIRNESS AND EQUITY) BE OUR PREFERRED. APPROVED BY COMMITTEE 2. Status of Detailed Economic Model for South Atlantic. The committee discussed the list of data needs for net benefit analyses and is recommending that these data be collected. They also reached the following conclusion: "Net Benefit Analyses – The theoretical model used for red grouper in the Gulf of Mexico has application for use in the South Atlantic, however, data are not available to complete the necessary analyses for the 10 species in Snapper Grouper Amendment 17. This type of approach could be utilized in the future as the data become available and the net benefit analyses are completed. These analyses should be completed as soon as practicable after the data are collected."

Option 1.	Recommend the data be collected for use in future analyses (for
	documents after the Comprehensive Allocation Amendment).
Option 2.	Modify (need to specify changes) and recommend approval of data collection.
Option 3.	Others??

3. Allocate by Four Sectors (For-Hire, Private, Commercial & Conservation). The Committee will discuss these allocations and present the following motion to the Council for approval to provide staff guidance on the alternatives to be developed in the Comprehensive Allocation Amendment: (Note: For-hire, private & commercial catch percentages are shown on the next page.)

**MOTION #1:** RECOMMEND THAT THE COUNCIL, IN THEIR DELIBERATIONS, ALLOCATE AMONG FOUR SECTORS: (1) COMMERCIAL, (2) RECREATIONAL, (3) FOR-HIRE, AND (4) CONSERVATION. APPROVED BY COMMITTEE (4 in favor, 3 opposed with concern about adding item 4. conservation)

## C. Review Status of Data Requests (Attachments 2 & 3)


Council staff will review the status of requests made by the committee.
