## SUMMARY REPORT FROM THE ADVISORY PANEL COMMITTEE MEETING (CLOSED SESSION) Jekyll Island, GA March 3, 2010

The Advisory Panel Selection Committee reviewed applications for openings on the Coral Advisory Panel, Golden Crab Advisory Panel, the Habitat and Environmental Protection Advisory Panel, the King and Spanish Mackerel Advisory Panel, the Law Enforcement Advisory Panel, Shrimp Advisory Panel, and the Snapper Grouper Advisory Panel.

The Committee noted a request to have a member of the Coral AP with deepwater coral experience serve on the Golden Crab AP. Staff was directed to contact all members of the Coral AP to solicit participation. If a Coral AP member is willing to serve on the Golden Crab AP, that person would replace a seat currently open on the Golden Crab AP and the additional seat would not be advertised.

An open seat for a conservation representative on the Georgia sub-panel of the Habitat and Environmental Protection AP will be readvertised to replace Dr. Charles Belin. The US Fish & Wildlife Service has designated John Ellis with the Ecological Field Office in Raleigh, NC as their representative for the NC Subpanel of the Habitat AP.

The Committee acknowledged the appointment of Amber VonHarten as the designated Sea Grant representative on the Information and Education Advisory Panel.

Regarding the selection of applicants for the SEDAR Pool, the Committee recommended staff publicize the opportunity for participation in SEDAR Data Workshops via the *South Atlantic Update* newsletter and the Web site, noting the level of commitment required by participants. The Committee also recommended staff contact all current AP members to advise them of the SEDAR Pool and their possible consideration for participation in future workshops.
