

**SUMMARY REPORT
FROM THE ADVISORY PANEL SELECTION COMMITTEE MEETING
Charleston, SC
September 16, 2010**

The Advisory Panel Selection Committee met September 16, 2010 and reviewed applications for seats on the following advisory panels: Coral AP, Habitat and Environmental Protection AP, Information & Education AP, King and Spanish Mackerel AP, Law Enforcement AP, and the Snapper Grouper AP. The Committee also reviewed applicants for the SEDAR Pool for possible participation in future SEDAR stock assessments, and discussed inactive advisory panels.

The Committee acknowledged the appointment of a USFWS representative on the Information and Education AP and Law Enforcement AP.

MOTION #6: APPOINT MARK ROGERS TO THE LAW ENFORCEMENT AP.

MOTION #7: APPOINT JOHN CLARK TO THE LAW ENFORCEMENT AP.

MOTION #8: RE-APPOINT STEVE AMICK, SCOTT OSBORNE, AND MARK MARHEFKA TO THE SNAPPER GROUPE AP.

MOTION #9: APPOINT JIM ATACK TO THE SNAPPER GROUPE AP.

MOTION #10: RE-ADVERTISE AN OPEN SEAT ON THE SPINY LOBSTER AP.

MOTION #11: APPOINT JIMMY HULL, CRAIG ANDREWS AND JOHN BARBER TO THE SEDAR POOL.

MOTION #12: DISBAND THE CALICO SCALLOP AP, PROTECTED RESOURCES AP, AND THE MARINE PROTECTED AREA AP, AND THANK THE MEMBERS FOR THEIR SERVICE.
