<sup>(</sup>a) Commercial harvest is prohibited during January 1-April 30 of each year.
(b) The use of black sea bass pots is prohibited annually from November 1 through April 30.
(c) NOAA Fisheries has removed blueline tilefish from the Deep-water Complex. This rule became effective on March 30, 2015. Additionally, there is now a trip limit of 100 lbs gutted weight for commercial harvest of blueline tilefish.
(d) The 2015 landings of blueline tilefish represent 74.03% of the previous ACL of 112,207 lbs ww.
