

Nightly Job Data Processing

Nightly Job Process

- Unattended/Automated process

- With logging and email reporting to data managers

- Landings report updates automatically incorporated

Aggregate by ACL

- Expansions calculated for missing landings reports

- Report landings, expansions, and forecasts



Expansions & Forecasts

- Expansions address non-reporting (should have reported)
- Forecasts predict future landings
- Landings, Expansion, and Forecast by Dealer
- As landings are reported expansions replaced with actuals





If dealers report on time, expansions are not needed


Prior Year Same Day Ratio



Quota Percentage






Percent Landed (Reported + Expanded)






Commercial Landings Monitoring system Status

- The largest improvement in monitoring will be federal permits for all dealers and timely reporting
- SEFSC software is considered stable
 - Improvements (tweaks): open/close dates, previous fishery tracking, further reporting improvements
 - Improved expansion and forecasting methods
- **Data issues remain the primary area of concern**




Commercial Landings Monitoring system

- Successes
 - Improved standardization of e-reports especially Bluefin Inc
 - SEFSC personnel now focusing on data
 - Monitoring ~ 50 ACLs, could do more
 - QMS (2010) monitored 15 groups
 - dealers file 1 report, not multiple





Improved monitoring capacity

 - Refined forecast methods
 - Bluefin Inc. standardization (GSMFC)
presumably later other areas (NEFSC, NC)
 - Automated compliance system (vessels
and dealers) being developed
