Dear Mr. Harris,

We are writing to respectfully request your consideration of a catch shares (LAP) program for the South Atlantic snapper grouper fishery. Our fishery is in trouble, and we are very concerned about the upcoming closures and potentially significantly reduced total allowable catches/ annual catch limits.

Catch shares are in place in the Gulf of Mexico and elsewhere in the United States and around the world. We are hearing more and more from these fishermen that catch shares are working. Fishermen are catching less fish and making more money, are freed from much of the "red tape" associated with traditional management measures.

Whether voluntary or not, we want to see a catch shares program considered and analyzed for all 73 species in the snapper grouper fishery to improve the economics of the fishery and ease other restrictions, to the extent possible, such as season closures or large area closures. We are all good stewards of the resource and want to see healthy fishery and a thriving commercial industry. We think catch shares is the way to end overfishing while still being able to make a living as commercial fishermen.

We understand that a Snapper Grouper LAP Workgroup met over a year period and developed recommendations for a snapper grouper catch shares program. We urge the Council to revisit the final Workgroup report for guidance and initial fishermen input on design.

To this end, at the June 2009 Council meeting, we would like the full Council to consider a snapper grouper limited access privilege program (LAP) amendment to begin development and analysis of catch shares for the snapper grouper fishery.
