1. Adjustment to hogfish fishing levels and management measures in response to stock assessment
2. Adjustment to spawning season closure for shallow water grouper
3. Modify the recreational bag limit for black sea bass
4. Adjustment of size limit for red grouper
5. Restructuring of the Jacks Complex and trip limit for almaco jack
6. Removal of size limits for deepwater species (silk snapper, queen snapper, and blackfin snapper)
