A BILL

To amend the Magnuson-Stevens Fishery Conservation and Management Act to extend the authorized time period for rebuilding of certain overfished fisheries, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Flexibility in Rebuild-
- 5 ing American Fisheries Act of 2007".

1	SEC. 2. EXTENSION OF TIME PERIOD FOR REBUILDING
2	CERTAIN OVERFISHED FISHERIES.
3	Section 304(e) of the Magnuson-Stevens Fishery
4	Conservation and Management Act (16 U.S.C.
5	1854(e)(4)) is amended—
6	(1) in paragraph $(4)(A)$ —
7	(A) in clause (i) by striking "possible" and
8	inserting "practicable"; and
9	(B) by amending clause (ii) to read as fol-
10	lows:
11	"(ii) not exceed 10 years, except in
12	cases where—
13	"(I) characteristics of the biology
14	of the stock of fish, other environ-
15	mental conditions, or management
16	measures under an international
17	agreement in which the United States
18	participates dictate otherwise;
19	"(II) the Secretary determines
20	that such 10-year period should be ex-
21	tended because the cause of the fish-
22	ery decline is outside the jurisdiction
23	of the Council or the rebuilding pro-
24	gram cannot be effective only by lim-
25	iting fishing activities;

1	"(III) the Secretary determines
2	that such 10-year period should be ex-
3	tended to provide for the sustained
4	participation of fishing communities
5	or to minimize the economic impacts
6	on such communities, provided that
7	there is evidence that the stock is on
8	a positive rebuilding trajectory;
9	"(IV) the Secretary determines
10	that such 10-year period should be ex-
11	tended for one or more stocks of a
12	multi-species fishery, provided that
13	there is evidence that those stocks are
14	on a positive rebuilding trajectory; or
15	"(V) the Secretary determines
16	that such 10-year period should be ex-
17	tended because of a substantial
18	change to the biomass rebuilding tar-
19	get for the stock of fish concerned
20	after the rebuilding plan has taken ef-
21	fect."; and
22	(2) by adding at the end the following:
23	"(8) If the Secretary determines that extended
24	rebuilding time is warranted under subclause (III),
25	(IV), or (V) of paragraph (4)(A)(ii), the maximum

1	time allowed for rebuilding the stock of fish con-
2	cerned may not exceed the sum of the following time
3	periods:
4	"(A) The initial 10-year rebuilding period.
5	"(B) The expected time to rebuild the
6	stock absent any fishing mortality and under
7	prevailing environmental conditions.
8	"(C) The mean generation time of the
9	stock.".
