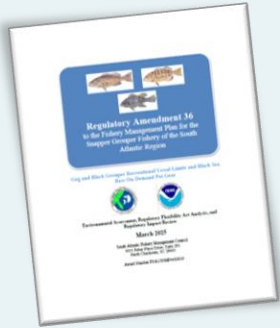
**WE SHOULD JUST BE ABLE TO SAY
“CREATE A HEADBOAT VESSEL LIMIT FOR
GAG, BLACK GROUPPER, AND
SCAMP/YELLOWMOUTH RIGHT?**

WRONG! We need to consider several things, including:

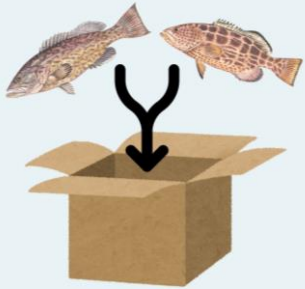
- **Current recreational retention limits**
- **What defines a headboat (because we do not have sector separation)**
- **How current regulations are written**
- **Amendments that are soon to be implemented but are not currently**



GAG AND BLACK GROUPEY: Initial Considerations



Amendments not in place yet: For the purposes of this amendment, we are going to assume that Regulatory AM 36 is implemented. It is currently in the proposed rule phase (as of May 2026).



How the species are lumped: Gag and black grouper will be treated as a single species because the retention limits match for both.



Action verbiage: Because there is already a vessel limit in place for these species, the action pertaining to them will use the language “**revise**” instead of “establish”.

GAG AND BLACK GROUPER: Current Recreational Retention Limits

Bag limit - 1 fish per person per day for gag and black grouper.

Private Recreational Vessel Limit - 2 fish, either gag or black grouper in any combination, per vessel per day

For-Hire* Vessel Limit - 2 fish, either gag or black grouper in any combination, per vessel per day. Captain and crew may not retain.
*For-hire refers to charter and headboat vessels

But Remember - The most restrictive limit is what applies!

GAG AND BLACK GROUPER: Current Recreational Retention Limits



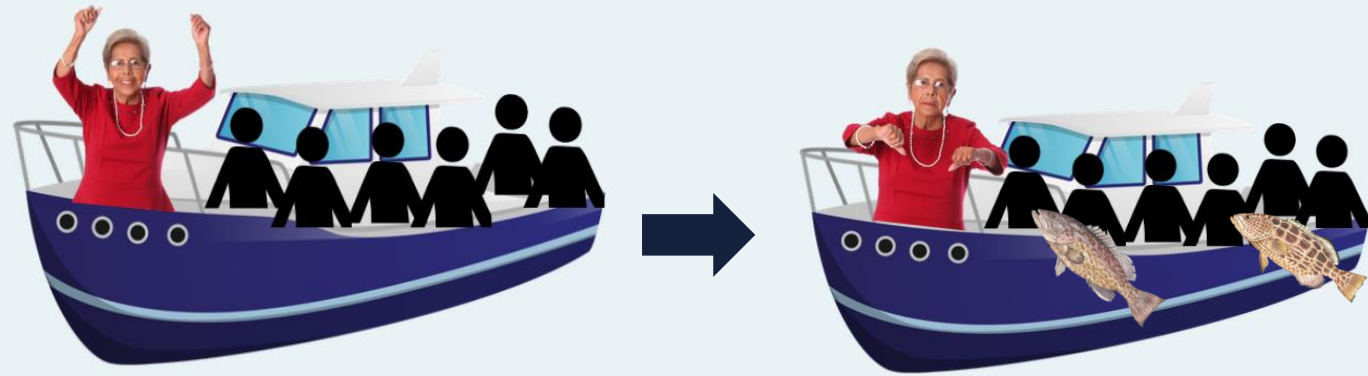
Bag limit - 1 fish per person per day for gag and black grouper.

Private Recreational Vessel Limit - 2 fish, either gag or black grouper in any combination, per vessel per day

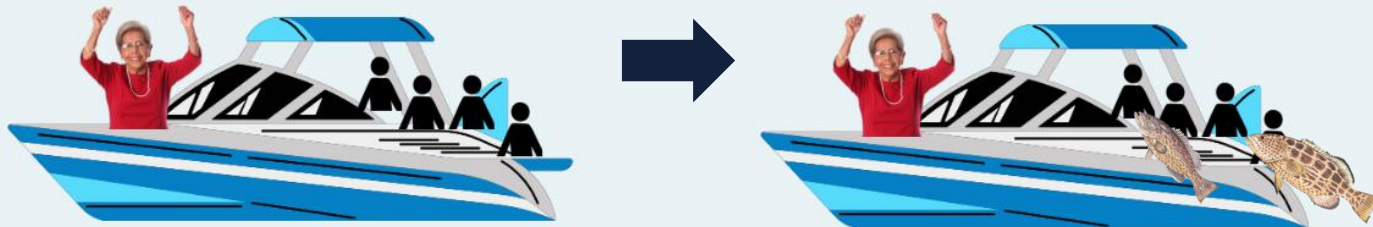
For-Hire* Vessel Limit - 2 fish, either gag or black grouper in any combination, per vessel per day. Captain and crew may not retain.
*For-hire refers to charter and headboat vessels

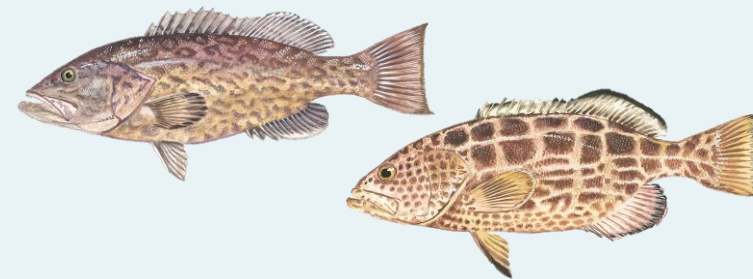

Now if the Herlinda's Fishing Adventures headboat goes fishing with 24 people, AND her vessel has a valid USCG issued COI...

Here Herlinda would be able to retain **1 fish per 6 passengers**, she has 24 passengers on board so they can retain 4 fish. If she had 30 passengers (the next largest group of 6) on board that would bump her up to 5 fish

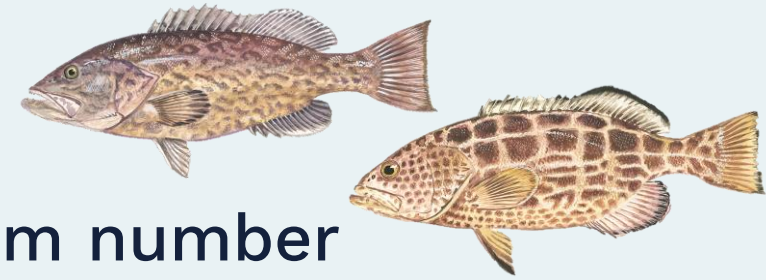


Here Herlinda would be able to retain **2 fish per 6 passengers**, she has 24 passengers on board so they can retain 8 fish. If she had 30 passengers (the next largest group of 6) that would bump her up to 10 fish.

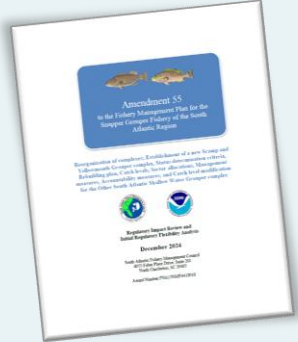

SCAMP AND YELLOWMOUTH GROUPER: Initial Considerations



Amendments not in place yet: For the purposes of this amendment, we are going to assume that Amendment 55 is implemented. It is currently in the final rule phase (as of May 2026).



How the species are lumped: Scamp and yellowmouth grouper will be treated as a single species because Amendment 55 will now lump them together as a single species.



Action verbiage: Because there is not a vessel limit in place for these species, the action pertaining to them will use the language “**establish**” instead of “revise”.

SCAMP AND YELLOWMOUTH GROUPER: Current Recreational Retention Limits

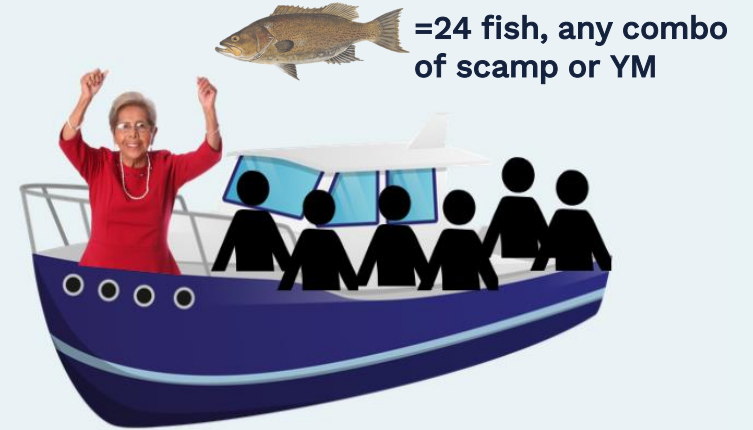

Now if the Herlinda's Fishing Adventures headboat goes fishing with 24 people, AND her vessel has a valid USCG issued COI...

Before, Herlinda could retain 24 fish but under a "per 6 passenger" vessel limit of 1 or 2 fish per 6 passengers, Herlinda can only retain 4 or 8 fish per vessel, respectively.
