- Gear Restricted Area and Weak Hook Amendment (Proposed rule): Will consider changes to the area-based and weak hook management measures for bluefin tuna in the pelagic longline fishery, with a focus on measures that were implemented to reduce dead discards of bluefin tuna. The rulemaking is intended to determine if existing area management and weak hook measures remain appropriate to both achieve the current management objectives and provide flexibility to adapt to fishing variability in the future.
- Amendment 13 Scoping: Will consider modifications of the bluefin tuna regulations, specifically, the Individual Bluefin Quota Program (pelagic longline fishery), modification of the directed tuna fishery quota system (rod and reel and harpoon gear), and sunsetting the purse seine fishery.
- Amendment 14 Scoping: Will consider a review of current HMS process for establishing the acceptable biological catch (ABC) and annual catch limits (ACLs) for domestically managed sharks, and a review of the process governing the distribution of the ACL to the various sectors.
- Spatial Management Scoping: Will consider options to conduct research and collect both fishery-dependent and fishery-independent data in areas currently closed to fishing for Atlantic highly migratory species.

Voices of the Southeast Oral History

The NOAA Southeast Oral History Kiosk will be set up outside the meeting room.
