a) FHER: For Hire Reporting Amendment

This amendment was submitted to the agency on March 3, 2017. SERO has convened a group called “SEFHIER” to develop reporting requirements and practices to address both the SAFMC and GMFMC reporting amendments. A proposed rule addressing SAFMC requirements is expected to publish prior to this meeting.

b) SAFMC Pilot Reporting Project

The cooperative project with ACCSP addressing electronic reporting requirements ended in October 2017. The Committee will receive a presentation reviewing the tools developed and data submitted during the project.

c) For-hire reporting outreach

The Council received funding to conduct outreach on the impending charter vessel electronic reporting requirements. Outreach and training materials have been developed and outreach workshops have begun. The presentation will review the outreach project, approach, and planned activities.
