- Membership
 - Council Chairs, Vice Chairs, Executive Directors
- Meetings
 - Spring in the host region and Fall in Washington, DC
- Authority
 - Organized as an Advisory Panel per the MSA and acknowledged in Council SOPPs.
 - Meetings fall under the same provisions as Council meetings

CCC Host Council

- One Council serves as host each year
- Rotating schedule
 - MAFMC is hosting in 2022
 - GMFMC in 2023
 - SAFMC hosted in 2019
- Duties
 - Organize CCC meetings
 - Maintain CCC website
 - Host Council Chair chair's CCC meetings
 - Serve as NMFS POC
 - Submit correspondence on behalf of CCC

- Comment on NMFS Technical Guidance
- Develop positions on MSA and related legislation (ESA, NEPA)

Subcommittees and Working Groups

- Science Coordination Subcommittee (SCS)
 - aka 'National SSC'
 - Chairs and Vice Chairs from each SSC
 - Council staffs support
 - Meet every other year to address national scientific topics
 - SSC practices, ACL implementation, ABC Control rules, Uncertainty, MSE's
- Legislative Working Group
 - Council staff and Council members
 - Reviews legislation and develops CCC positions
 - Manages the CCC legislative working paper and documents
 - CCC Position and Individual Council Positions

Subcommittees and Working Groups

- Habitat Working Group
 - Council Staff
 - Develop positions and information for CCC consideration
 - EFH, Habitat policy review, Area-based management, 30x30 effort
- CMOD Working Group
 - Council Member Ongoing Development
 - Replacement for the "Fisheries Forum"
 - Biannual training sessions for Council Members
 - 2022 Workshop
 - Ecosystem-Based Fisheries Management
 - SAFMC representatives: Jessica, Carolyn, and Kerry
