#### Minutes Approval – December 2019

#### 1. Council Priorities (Attachment 1)

Brian Cheuvront will give the committee an update on the Council's FMP priorities (Attachments 1a and 1b). The Council approved these priorities and the overall meeting plan for 2020 in September 2019, and at each meeting is asked to review progress and update the plan as necessary. The Council Follow-up provides a detailed listing of all Council activities and active amendments (Attachment 1c).

#### 2. Gulf and South Atlantic Joint Workgroup on Recreational Flexibility (Attachment 2)

During the CCC meeting in November 2019, representatives of the Gulf and South Atlantic Councils suggested convening a joint working group to respond to the Modern Fish Act. The SAFMC identified representatives to the working group in December 2019 and submitted a letter to the GMFMC in January 2020 conveying the names and expressing the Council's support for the working group. The GMFMC discussed the working group in January 2020.

#### **3.** Council Practices and Polices

Award of Excellence: The Committee discussed creating an SAFMC Award of Excellence during the October 2019 webinar meeting. The award will recognize those who have made noteworthy contributions to the Council's management programs. Further guidance was provided in December 2019, at which time the Committee directed staff to develop a proposal to address the award nomination and selection process (**Attachment 3a**).

Council Committee Structure: During a recent Council-Staff leadership retreat, it was noted that the SAFMC has many committees, some that seldom meet and other with overlapping responsibilities. A proposal is detailed in **Attachment 3b** to revise and consolidate SAFMC committees.

Handbook Revisions: Some topics discussed during this Council meeting, and planned for discussion at future meetings, will need to be addressed in the SAFMC Handbook. Because the Council previously expressed a desire to address handbook revisions and approval all at once, and information pertinent to some handbook revisions is not yet available, formal approval of a revised handbook will be considered at a later meeting. At this time, there is a plan to address specific policy items over the next few meetings, as detailed in the list below.
