South Atlantic Snapshot

- ➢ 187 Opened Incidents
- ➢ 8 Cases referred to General Counsel/US DOJ
- ➢ 25 Summary Settlements (\$300-\$2500)
 - Retention during closure/undersize possession
 - Descender Device Requirements
 - Observer Program Requirements, Fishing in Sanctuary
- Remaining were unfounded, boardings, fix-its, compliance assistance or WWs.
