### NOAA Fisheries' EEJ Strategy

- Establishes national framework for advancing EEJ through our mission-related work
- Requires regional implementation plans -due April 5, 2024

### Key Terms: Equity

*Equity* means the consistent and systematic fair, just, and impartial treatment of all individuals, including individuals who belong to underserved communities that have been denied such treatment.



Definition from Executive Order 13985.



### Key Terms: Environmental Justice

*Environmental Justice* is the fair treatment and meaningful involvement of all people, regardless of race, color, gender, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies including but not limited to:

- Equitable protection from environmental and health hazards
- Equitable access to decision-making processes
- Equitable opportunity for disadvantaged communities that have been historically marginalized



### Key Terms: Underserved Communities

*Underserved communities* have been systematically denied a full opportunity to participate in aspects of economic, social, and civic life.

These include geographic communities as well as populations sharing a particular characteristic such as: women and girls; Black, Latino, and Indigenous and Native American persons\*, Asian Americans and Pacific Islanders, and other persons of color; persons facing discrimination or barriers related to gender identity; members of religious minorities; lesbian, gay, bisexual, transgender, and queer (LGBTQ+) persons; persons with disabilities; persons who live in rural areas; and persons otherwise adversely affected by persistent poverty or inequality.

## Key Takeaways

- For many, the contemporary situation is truly challenging
  - Many commercial participants emphasize that if problems related to seafood importation are not addressed quickly, they may need to leave the industry
  - Diminishing dock space and fewer working waterfronts are also perceived as major constraints around the region
  - Cumulative difficulties related to permit costs, limited availability of crew members, and fuel expenses are commonly said to be diminishing intergenerational involvement in marine fisheries

## Key Takeaways

- Underserved persons often do not feel decision-makers understand, consider, or represent their perspectives and viewpoints
- Members of underserved communities often feel exploited by coastal land developers and federal projects such as offshore wind and others
- People from underserved communities are depending on us to partner with each other and other state and federal agencies to find solutions

### Action Items - Methodology and Types

#### • Methodology

- Formulated from responses to Request for Information, focus group meetings, scoping, other informal meetings/conversations
- Drafted potential performance metrics
- Organized by national objective
- Incorporated sorting/ranking criteria (short-term/long-term, funded/unfunded, +)

#### • Types

- Green -- seemingly straightforward, primarily related to accessibility
- Yellow -- may need to further consider roles, responsibilities, applicability
- Pink -- adopted from national EEJ strategy
- Blue -- other commonly heard/requested items acknowledged but not addressed in regional EEJ implementation plan (e.g., perceived sector inequities, enforcement)

### Action Item Types - Research & Monitoring

Identify underserved communities and their needs, conduct collaborative research, and assess impacts of management decisions

- Community Focus
  - Identify and assess needs of underserved communities
  - Gather data on barriers and challenges in fishing and aquaculture participation

#### Equity Assessment

 Conduct equity assessments across fisheries value chain

#### • Impacts Analysis

- Evaluate impacts (services and management actions, climate change, offshore wind, and seafood imports)
- Compare projected vs. actual outcomes, consider cumulative effects

#### • Collaborative Research and Science

- Increase co-production and co-development of stock assessments
- Integrate local and traditional ecological knowledge into decision making process

#### • Additional Research Areas

• Explore significance of diversification, literacy issues, and addiction

### Action Item Types - Outreach & Engagement

Build relationships with underserved communities to better understand engagement preferences and improve information sharing

- Diverse Communication Channels (social media, mail, text, phone, community newspapers...)
- Inclusive Language Technology
  - Simple plain language
  - Tech support for virtual meetings
- Proactive and Tailored Outreach
  - Use special strategies for rural areas
  - Target underserved populations (e.g., women)
  - Identify or establish community liaisons for direct interaction
  - Review and adapt to all education levels
  - Leverage local insights for effective outreach

- Multilingual Stakeholder Support
  - Translate products
  - In-house multilingual liaisons for seamless communication

#### • Additional Strategic Initiatives

- Educational opportunities
- Language that emphasizes care and consideration
- Partnerships for addiction and mental health support

### Action Item Types - Policies & Plans

Ensure that our policies promote equal opportunities for all and do not create unintended inequities or unequal burdens for underserved communities

#### • Equitable Access

- Offshore aquaculture
- Cooperative research
- Fishery disaster assistance
- Seafood and permit markets
- Decision making processes
- Cultural Awareness
  - Observers
- Two-Way Information Sharing
  - Climate research and response
  - Local ecological knowledge

- Streamlined and Transparent Information Collection
  - $\circ$  Surveys
  - Fishing permits

### Action Item Types - Benefits

Distribute benefits equitably by increasing access to opportunities

#### • Technical Support

- Grants
- Fishing permits
- Fishery disaster assistance

#### Educational Support

- Vocational training
- Scholarships, internships and mentorship programs

#### • Financial Support

- Grants (outreach and education, capacity building)
- Strategies to increase access to capital

#### • Other Supportive Measures

- Collaborative projects to preserve working waterfronts, protect fishing communities impacted by wind energy and other federal initiatives
- Strategies to remedy identified access or allocation disparities

### Action Item Types - Inclusive Governance

Enable the meaningful involvement of underserved communities in decision-making processes

#### Engagement Enhancement

- Public meetings and input processes; research, monitoring, and science
  - Logistics and scheduling
  - Communication strategies
  - Partnerships and financial assistance

- Representation on Advisory and Decision bodies
  - Fishery Management Councils
  - Take Reduction Teams
- Educational Initiatives
  - Informational materials
  - Marine Resources Education Program

### Action Item Types - Empowering Environment Provide institutional support to implement EEJ

#### • Training

- Specialized -- observers, port agents, grant reviewers
- Plain language -- All staff
- EEJ -- All staff, Council members, APs, and Committee members

#### Interagency Workshops

- Resource and information sharing
- Partnerships to address cross-jurisdictional challenges

#### • Resources to Support this Work

- FTE anthropologists / non-economic social scientists at SERO and SEFSC
- $\circ\,$  EEJ Coordinators at SERO and SEFSC
- $\circ\,$  Funding to Councils for EEJ Coordinators
- EEJ funding strategy
