Overview

- 1. The Council Chair will introduce the liaisons from other Councils taking part in Committee deliberations.
- 2. New and reappointed Council members will be sworn in by SERO Regional Administrator, Roy Crabtree.

3. Executive Order on Promoting Fisheries

Description: On May 7, 2020 the President signed Executive Order 13921 on Promoting American Seafood Competitiveness and Economic Growth, "to strengthen the American economy; improve the competitiveness of American industry; ensure food security; provide environmentally safe and sustainable seafood; support American workers; ensure coordinated, predictable, and transparent Federal actions; and remove unnecessary regulatory burdens". NOAA Fisheries requested that each Council submit a prioritized list of recommended actions to reduce burdens on domestic fishing and to increase production within sustainable fisheries as required under Section 4 of the order by November 2, 2020. The Committee will review the Executive Order and further develop a draft list of topics for consideration by the Council at the September 2020 meeting.

Council Action: Review/refine the preliminary list of topics (**Attachment 1**) developed by the Executive Committee at their August 2020 meeting to include in the SAFMC EO response.

4. Emergency Action Requests Status

At the June 2020 meeting, the Council requested two emergency actions to help fishermen impacted by the unforeseen global events of 2020. The Council requested that NOAA increase the Atlantic recreational King Mackerel possession limit to 4 per person coastwide. And the Council requested that NOAA increase the commercial trip limit for Vermilion Snapper to 1,500 lb gw for 180 days. The formal letters requesting the actions for King Mackerel and Vermilion Snapper were sent to SERO on July 1, 2020.

5. Additional Emergency Action Considerations

In June 2020 the Council directed staff to bring an emergency action request for consideration in September to allow carryover of unused 2020 species ACL into 2021. This document (**Attachment 2**) will give a brief overview of the guidance and review how carryover could be applied in the South Atlantic region for Spanish Mackerel, Vermilion Snapper, and Yellowtail Snapper.

Council Action: Discuss the ACL carryover guidance provided in the paper and decide whether to request emergency action for ACL carryover for Spanish Mackerel, Vermilion Snapper, and/or Yellowtail Snapper.

6. SBRM Report on Topics for Amendment Development

The Sustainable Fisheries Act (1996) amended the MSA to require all FMPs establish a standardized bycatch reporting methodology (SBRM). A formal rule was published in 2017. All FMPs must be consistent with the rule by February 21, 2022. Councils are required to review all of their FMPs in coordination with NMFS to evaluation their consistency with the rule. NMFS SERO will present information (**Attachment 3**) about the SBRM rule and the

process of how NMFS and the Council will work together to make sure all the Council's FMPs are compliant.

Council Action: Discuss the method to be used and provide guidance.

7. Allocations Options, Data, and Analyses

Council staff will give a presentation (**Attachment 4b**) outlining a possible Decision Tree Approach method the Council may want to consider as a way to determine which information is relevant to help decide if allocations should be revised, or how they might be revised. The method is described in greater detail in **Attachment 4a** together with examples and related data.

Council Action: Discuss the concepts presented and provide direction as to whether they would like staff to continue future development and review of the Decision Tree Approach to help the Council make allocation decisions.
