



#### Emergency Protections - 2023

- Temporary Special Use Area
- 60 days with potential for one, 60-day extension
- Entry prohibited except for conducting restoration activities under permit
- Continuous transit without interruption allowed
- First emergency rule since 2003

### Proposed Emergency Protections - 2024

What's Different:

- Informed by 2023 emergency rule
- Three temporary Special Use Areas (instead of one)
- Taking public comment (to inform future management action)


What's the Same:

- 60 days with potential for one, 60day extension
- Entry prohibited except for conducting restoration activities under permit
- Continuous transit without interruption allowed
- Area includes 200-yard buffer around coral relocation site

### Tavernier Special Use Area (Temporary)

- same location as 2023 temporary special use area
- approximately five miles southeast of the community of Tavernier
- approximately 0.068 square miles



### Marathon Special Use Area (Temporary)

- approximately 4 miles offshore from the City of Key Colony Beach/Marathon
- approximately 0.066 square miles

### Looe Key Special Use Area (Temporary)

- approximately 6.5 miles offshore from Summerland Key
- approximately 0.069 square miles

# Status & Next Steps

- Draft emergency rule is in NOAA clearance, DOC following that
- When published, the rule will be in effect
- 30-day Public Comment Opportunity
- Communicating with agency partners, sanctuary advisory council, and affected constituents
- USCG will issue notice to mariners



# Future Management/Rulemaking Action

#### <u>30-day Public Comment Opportunity with the 2024 emergency rule</u>

- solicit input on a proposed long term solution -
  - conduct a full rulemaking to establish permanent offshore zone(s)
  - zones would be used and regulations applied on an as needed and temporary basis
  - when the zone(s) are needed, NOAA would notice the public through a Federal Register Notice and other local communication channels

#### If a full rulemaking is undertaken, this would trigger:

- environmental and economic analysis
- public notice and comment
- agency coordination and consultation
- consultation with Fishery Management Councils through the 304(a)(5) process
