

Enforcement and Compliance


<u>Summary</u>


Data represent National Oceanic and Atmospheric Administration Fisheries Office of Law Enforcement (NOAA OLE) Southeast Division's (SED) enforcement effort conducted throughout FY Quarter 3 2020, **April 1, 2020- June 30, 2020**. When appropriate, information is separated by council, South Atlantic Fishery Management Council (SAFMC), Gulf of Mexico Fishery Management Council (GMFMC) and Caribbean Fishery Management Council (CFMC). There were **78** documented patrols, allowing critical face-to-face interaction between our field staff and the industry; **33** documented instances of outreach (not an exhaustive list; includes phone calls with industry, dock visits, trade shows, presentations, etc.); and **7** meetings. This list does not include the extensive outreach that the Investigative Support team provides on a daily basis, nor can it fully capture the interaction our agents, officers, and support staff regularly have with industry.



Incident Information

During the third quarter, NOAA OLE opened **223** incidents in the SED, which included 224 violation counts- **140** incident violation counts in the SAFMC area, **93** incident violation counts in the GMFMC area and **9** incident violation count in the CFMC area¹. Opened incidents originate from both NOAA personnel and our enforcement partners.







Summary of Incidents By Joint Enforcement Agreement and United States Coast Guard Partners

Throughout Quarter 3 2020, there were **44** incidents referred to NOAA OLE through Joint Enforcement Agreement (JEA) and United States Coast Guard (USCG) partners. Below is a summary showing the overall distribution of incidents initiated by partner, and a breakdown of incident counts by law/regulation/program per enforcement partner¹. Effort consisted of dockside vessel inspections, offshore vessel boardings and interaction with public and industry members.



Enforcement Highlights

Lacey Act

Raymond M Torres-Ramos pled guilty in Puerto Rico Federal Court (via video conference) to three felony counts of Export Smuggling (18 USC 554 and 2), Lacey Act Wildlife Trafficking (16 USC 3372(a)(2)(A), and Lacey Act False Labelling(16 USC 3372(d)(2). Torres and another subject were illegally harvesting ricordea, zooanthids and live rock from Puerto Rican waters and selling the marine life in interstate and international commerce. This is the final investigative spinoff of a long term operation initiated out of the Florida Keys. The operation targeted the illegal harvest and sale of ricordea coral, live rock and various marine life species.

Marine Mammal Protection Act

A special agent (SA) with from Corpus Christi, Texas, conducted a land patrol by hiking to the horseshoe cove where a potentially trapped dolphin had been reported on North Padre Island. A bottlenose dolphin was located on the southern portion of this cove. The dolphin surfaced every 2-5 minutes during an hour of observation and seemed to show no signs of distress. No other human or vessel traffic was observed in the area. Water lines observed from the previous week's high tides appeared to provide more than enough depth at the mouth of the cove for the dolphin to leave this area.

Magnuson-Stevens Fishery Conservation and Management Act

A SA from the Jacksonville, Florida field office assisted with and received a Joint Enforcement Agreement (JEA) case package of a recreational fishing vessel in possession of snapper/grouper species not in whole condition (fillets) at sea. The subjects admitted to the fillets being red snapper after officers started taking DNA samples. The DNA samples were sent to the NOAA Forensics lab for species identification and confirmation.

A SA from the Jacksonville, Florida field office assisted FWC with an incident of a commercial fisherman being over the daily commercial trip limit of 4,000 lbs. of Spanish mackerel. The vessel exceed the limit by 538 lbs. The SA also field assisted FWC with an incident of a commercial bottom longline fishing vessel going on a fishing trip with expired permits. FWC boarded the vessel while it was offloading product. The vessel offloaded approximately 2,032 lbs. of golden tilefish, 93 lbs. of blue line tilefish, and 96 lbs. of snowy grouper. The SA checked the permits and they had been expired for the last 3 months. The vessel has since renewed the permits and a SS was issued.

Enforcement Officers (EO's) from Charleston, South Carolina and Savannah, Georgia conducted a JEA Patrol with Georgia Department of Natural Resources (GDNR) to offshore reefs out of Savannah and boarded nine vessels. One recreational vessel was found with five undersize Black Sea Bass, use of J-hooks, and using Black Sea Bass for bait and a second recreational vessel was found with one undersized Black Sea Bass. Summary settlements and compliance assistance were provided.

Endangered Species Act



An EO, SA, and ASAC from Galveston, Texas coordinated and conducted two patrols due to an increased number of Sea Turtle strandings in the area. The team examined TEDs while they were in the water alongside the shrimp vessel. The operation was a success as 10 active shrimp vessels were located, contacted, and the gear was examined. No violations were found.

An EO from Galveston, Texas conducted multiple joint TED patrols with the USCG in, Texas. Officers completed two TED boardings and three at-sea boardings on recreational fishing vessels, where two vessels were found with violations. One vessel possessed yellowfin tuna and did not have a valid HMS Angling permit. Compliance assistance was provided after the owner/operator immediately purchased the permit. The other vessel was found in possession of 21 red snapper fillets hidden in the engine compartment.



An EO from Houma, Louisiana conducted a beach patrol along Grand Isle Beach. During the patrol, the EO identified two dead Kemp Ridley sea turtles that washed ashore. One Kemp Ridley was kept due to a possible gunshot wound to the back of the shell. The turtle was sent to Audubon

Nature Institute in New Orleans to conduct radiograph testing.

An EO from Galveston, Texas completed an underway TED patrol with TPWD offshore Sabine, Texas. One TED boarding was completed on a commercial shrimp-fishing vessel which possessed a TED forward cuts less than 26-inches. A SA and EO from Galveston, Texas completed a beach patrol of the Galveston and High Island beaches due to the increase of sea turtle stranding's in the area. They provided education to patrons during the patrol. No stranded turtles were observed.



NATIONAL MARINE SANCTUARIES

EO's from St Petersburg, Florida conducted a weeklong, multi-mission OLE patrol in Key West, Florida. In addition to the law enforcement patrol, the crew provided logistics support to the National Weather Service (NWS) by transporting two technicians to Sand Key Light and Sombrero Key Light weather stations. The technicians successfully repaired the previously malfunctioning equipment. Weather data from the two stations is now available to

mariners. The crew documented Florida Keys National Marine Sanctuary Act violations on two recreational vessels. In both instances, the crew observed subjects attempting to commit violations and intervened, thus closing the encounters with compliance assistance. The crew documented Magnuson Act violations on two commercial fishing vessels.

COOPERATIVE ENFORCEMENT / PARTNERSHIPS

An EO from New Bern, North Carolina observed a vessel cutting fish approximately 50 yards off a local boat ramp prior to landing. By observing the vessel through binoculars it was determined that the fish in question were Weakfish which fall under state regulations. North Carolina Marine Patrol (NCMP) was contacted, a boarding was completed to verify catch, and the incident was turned over once the state Officer was on scene.

PATROL / VMS / CATCH SHARES

An EO from New Bern, North Carolina conducted a patrol of Topsail Island and Surf City, North Carolina for the annual Atlantic Bonito run which has still brought many fishermen to the area. Two separate patrols were also conducted in Oriental, North Carolina. EO's from Charleston, South Carolina and Savannah, Georgia conducted TED outreach patrols at Port Royal and St. Helena Island, South Carolina. The EO's provided nine courtesy TED measurements. A similar effort was conducted in Cherry Point which four TED's were measured. Compliance assistance was provided on four TED's.

A SA from Slidell, LA and an EO from Houma, LA conducted a beach patrol of Grand Isle beach and Elmer's Island beach. The area has seen a high number of sea turtle and dolphins stranding's recently. No stranded sea turtles or dolphins were located during the patrol of the beach area. The SA and EO did locate a bundle of marijuana on Elmer's Island beach that has been turned over to the appropriate agency for destruction.

An EO from New Bern, North Carolina conducted patrols of Morehead City, Radio Island, and Beaufort, North Carolina focusing on the Big Rock Blue Marlin Tournament. During the patrols numerous contacts were made and questions answered for the public. NOAA OLE was well received by the tournament staff and was asked to participate in measuring the fish that were brought to the dock.

EO's from Charleston, South Carolina and Savannah, Georgia conducted land based Marine Mammal Protection Act (MMPA) patrols of Broad Creek and Hilton Head Island, South Carolina due to reports of dolphin feedings. Dolphin activity was observed however no violations were observed.

COMPLIANCE ASSISTANCE/OUTREACH/EDUCATION/PUBLIC AFFAIRS/MEDIA

A SEO and EO from the St. Petersburg, Florida office met with local subjects within the commercial fishing industry and educated them on commercial fishing regulations. The officers also followed up on a complaint in reference to local boaters harassing dolphins. They documented no violations and provided education on MMPA regulations.



An EO from Savannah, Georgia conducted port operations with CBP and GA DNR at the Port of Savannah examining 18 shipping containers. No violations were found.

ADMINISTRATION/OTHER

The SED Compliance Liaison participated in a conference call with the OLE Observer Liaison Working Group. Divisional updates, incidents and concerns were shared with the group, including COVID-19 effects of observer deployments.

The Investigative Support team continues to work with the HMS office regarding modifications to Bluefin tuna management. Areas previously closed to fishing have opened up, with enhanced reporting measures through VMS units required. New forms and software updates have been sent to VMS vendors and areas in vTrack updated accordingly.

A St Petersburg, Florida SA and Compliance Liaison held status meetings with the three regional observer programs and SED GCES staff. Current concerns and safety plans regarding future deployments were discussed, related to COVID-19, as well as compliance issues and violations.

An EO from St. Petersburg, Florida and SA's from Sunrise and Jacksonville, Florida along with the



National Training Coordinator attended the memorial service of fallen Florida Fish and Wildlife Conservation Commission (FWCC), Division of Law Enforcement Officer Julian Keen, Jr. They were joined by hundreds of others who gathered to honor the officer who was killed while off-duty after he confronted a hit and run suspect.

Overview of Summary Settlements

Listed below is a summary of the **35** Summary Settlements issued during the quarter. Violations cited throughout the Gulf region ranged in subject and included four Catch Share/Individual Fishing Quota Program violations, two citations involving charter or other fishery activity without required permits and one TED/BRD citation. Violations throughout the South Atlantic region included two citations involving charter or other fishery activity without required permits and one Seafood Import Monitoring Program citation. The majority of violations in the Keys area consisted of activity within the Florida Keys National Marine Sanctuary areas.

Population Breakdown by (VMS) Fisheries and VMS Vendor

Violations ranging from fishing in a closed area, improper gear use and failure to comply with reporting requirements (trip declarations, daily reports, pre-landing notices) were detected by Investigative Support staff and referred to enforcement officers or special agents for follow-up. Additionally, staff conducted daily calls with the industry relating to compliance during the quarter.

The Investigative Support Program continues to work closely with NOAA Southeast Regional Office staff regarding the Gulf of Mexico For-Hire Reporting Amendment. Required hardware and software specifics to meet reporting requirements are in development. Federal rules have also been published regarding the new reporting, 85 FR 44005. <u>https://www.federalregister.gov/documents/2020/07/21/2020-15275/fisheries-of-the-caribbean-gulf-of-mexico-and-south-atlantic-electronic-reporting-for-federally</u>. NOAA OLE plans on hiring enforcement officers specifically for compliance and monitoring of the For-Hire Reporting Amendment and will be assisting the program as it develops.

The Investigative Support team has also worked with the HMS office regarding modifications to Bluefin tuna management. Areas previously closed to fishing have opened up, with enhanced reporting measures through VMS units required. New forms and software updates have been sent to VMS vendors and areas in vTrack updated accordingly.

Observer Program Highlights

During FY Quarter 3 2020; the Southeast Division Observer Programs deployed on **4** trips for **8** sea days. Coverage was reduced due to COVID-19 related concerns. Approximately **100%** of all selected trips were completed without an observer related enforcement incident [assault/harassment (sexual and non-sexual), safety]. Observer programs reported **6** fishery violations and International Convention for the Prevention of Pollution From Ships (MARPOL) violations to NOAA OLE. The Gulf of Mexico Shrimp Program deployed on 0 trips for 0 sea days, and the Gulf of Mexico Reef Fish Program deployed on 0 trips for 0 sea days. Effort for the Panama City Gillnet Program was 3 trips for 3 sea days, and the Panama City Bottom Longline Program (includes Shark Research Fishery) deployed on 0 trips for 0 sea days.
