I've been thru many amendments and never have I seen one with so many recreational data ""contradictions"". The gag sector allocations should not be changed, regardless of which set of landings data is correct because NOAA/S.A. Council have worked hard to create a very uneven comm./rec. playing field by their actions.They have,over the years, steadily reduced the number of S/G fishermen thru their 2 for 1 permit regulation and this regulation, unbelievably, is still in effect today.During the same time period, the rec. sector has had no restrictions on their numbers. From the fisheries.noaa.gov website the computed average of rec. gag landings for the 5 years period (2015-2019) mentioned in the Amendment 35 Document(53 Doc) is 109K lbs From the SEDAR 72, the average for the same 5 years is computed to be 255K lbsFrom the 53 Doc the given average is 297K lbsAll data was supposedly collected through ""valid" methodology and even with some tweaking due to different collection methods,there should not be this much discrepancy. When looking at the 3 years (17-19) rec. gag landings data one can determine that NOAA reported landings averaged 112K lbs The SEDAR shows a 269K lbs, and the 53 Doc. shows a 364 K lbs.If the 53 Doc data is correct, then the rec. sector allocation based on landings that exceeded their ACL is borderline ""criminal"". I urge you to keep the sector allocations that are currently in effect (51% Comm./49% Rec.). To decrease the Comm. sector allocation on top of the proposed overall ACL reduction will have a greater economic effect on N.C. and S.C. Comm. S/G fishermen since this is the area where the gag landings are concentrated.At my age and with my small boat, I can't make the trip 35-40 miles offshore to get to other species in deeper water. In you r 53 Doc. you quote a 56+ price for gag per pound. FX1., this past year it was \$8+ per pound. As to the assertion that gag gr

My name is Kurt Boyken. I am a resident of Merritt Island, FL. I have fished offshore in federal waters off Port Canaveral for the past ten years. I am studying environment studies at the University of Central Florida. I do not support prohibiting multiple hook rigs because it interferes with other types of fishing where red snapper either never existed or did not occur in numbers. In Gu Stream waters ranging from 80-800 ft, I target Uiefsh and yellowedge grouper on mud burrows. It requires several pounds of lead, and it takes a few minutes to get the baits down and up. I need to use multiple hooks because unwanted small benthic species will unhook my baits. I do not catch many red snapper over hard bottom spots deeper than 200 ft. In this depth, I strongly prefer to use two hooks when I target gray triggerfish, vermillion snapper, and red porgy (when season is open). I am intentionally bottom fishing this far offshore to avoid red snapper, so please do not prohibit multiple hook rigs or electric reels in depths greater than 200 ft. If your agency decides to prohibit multiple hook rigs anyways, please make it only apply to bait pleces larger than four inches. Except for targeting grouper, I am using small plece of bait to catch species other than red snapper in the aforementioned depths. If multiple hook rigs or electric fishing reels are prohibited, more people will fish shallower spots where red snapper are far more abundant. Electric reels and multiple hooks are less essential in less than 200 ft because less weight is needed, and less current is present. More people fishing in shallower would inevitably increase red snapper mortality. That said, my observations about red snapper do not indicate the need for prohibiting harvest in federal waters out of Port Canaveral, Florida. Please do not prohibit multiple hook rigs. I am all for sustainable fisheries, but all my experience from 100+ days on the water per year indicates

If the aim of Amendment 35 is to reduce mortality of Red Snapper by eliminating use of multi hook systems such as chicken rigs, then depth of water needs to be addressed. Fishing for tilefish and other deep water species is a chore, but is one of the only bottom fishing activities that anglers can engage in and not spend all their bait and time catching Red Snapper(the species is in an extreme abundance) and deep water bottom fishing is done almost exclusively with a multi hook rig to ensure that if you miss a bite you can continue to fish without having to reel All the way back to the surface and start all over again. Deeper than 300' of water it is uncommon to encounter red snapper, and deeper than 400' is practically unheard of. Disallowing anglers use of multi hook rigs while attempting to fish water at these depths and greater would have zero bearing on red snapper populations and should therefore be exempt form additional regulation. Furthermore, A reassessment of data and data collection on American Red Snapper as a species needs to be addressed. I've fished the east coast of florida for 20+ years, and in the last decade the population of red snapper has not only exploded, I believe it's become overpopulated. I fail to see how it's possible that this species is still considered in danger of over harvest. It is practically the only thing you catch while bottom fishing anymore. How is this data collected, by who, and when?
