#### **1. Habitat and Ecosystem Advisory Panel (HEAP) Report (*Attachments 1a and 1b*)**

**Description:** Stacie Crowe, SCDNR, HEAP Chair, will deliver the July 2025 HEAP report. Council staff will review the HEAP's Workplan that includes the following items to discuss during the Winter 2026 meeting:

- Review progress on the habitat program communication strategy
- 2025 Annual report
- Citizen Science Updates
- Essential Fish Habitat Consultation updates
- Revision of Alterations to Riverine, Estuarine and Nearshore Flows Policy to address impacts from freshwater discharges and impediments to river flow
- Update on impacts from space activities on habitat (if the information is available).
- Spawning Special Management Zones Working Group report
- Resilient Fisheries Projects overview and EFH project update
- Integrate food web information from food web policy into EFH definitions
- Work plan update

#### **2. Establish a Shrimp Fishery Access Area in the Oculina Habitat Area of Particular Concern (Coral Amendment 11/ Shrimp Amendment 12) (*Attachments 2a-2c*)**

**Description:** In 2021, the Council submitted Coral Amendment 10, which proposed establishing a shrimp fishery access area (SFAA) within the northern extension of the Oculina Habitat Area of Particular Concern (OHAPC) where trawling for rock shrimp is currently prohibited. In 2022, the Council received a letter of disapproval. Among the reasons for disapproval, NMFS stated that the amendment did not include adequate analysis to ensure that the proposed action would minimize adverse effects of fishing on essential fish habitat (EFH) and minimize bycatch. In September 2024, staff were directed to develop a joint amendment to the Coral and Shrimp FMPs to propose establishing an SFAA within the northern extension of the OHAPC and incorporate updated information, including a recent mapping study. In June 2025, the Council selected Preferred Alternative 2 and approved Coral Amendment 11/Shrimp Amendment 12 for public hearings. Hearings were held in August 2025. Staff will review a decision document that includes new edits to the alternatives, summary of analyses completed to date, next steps, and a public hearing comment summary.
