OVERVIEW Law Enforcement Committee

1. Law Enforcement Advisory Panel (LE AP) Report (Attachment 1)

Description: The LE AP met via webinar on February 1, 2021. The AP received updates on developing and recently implemented amendments and provided recommendations on proposed modifications to the Dolphin Wahoo, Snapper Grouper, and Coral FMPs. The AP also discussed proposed changes to the structure of the AP (see item below), held elections, and discussed the Law Enforcement Officer of the Year award program. The LE AP Chair, Captain Scott Pearce, will deliver the report to the Committee. **Required Committee Action:** Consider the AP's recommendations and provide guidance as appropriate.
