**Status:** Amendment 18 to the Coastal Migratory Pelagics FMP is being developed as a joint amendment. The Gulf Council is administrative lead and Rick Leard will be the staff person with primary responsibility; Gregg Waugh will be the South Atlantic Council staff person working on the amendment.

- 1. SAFMC STAFF CONTACT GULF COUNCIL STAFF TO INFORM THEM ABOUT THE SAFMC'S DECISIONS AND OFFER TO HOLD A JOINT MACKEREL COMMITTEE MEETING DURING THE SAFMC'S JUNE 2009 MEETING. **Done 3/10/09.**
- 2. REQUEST STAFF, WORKING WITH GULF & NMFS STAFF, PREPARE A DECISION DOCUMENT TO USE AT THE JOINT MEETING OUTLINING THE DECISIONS FOR THE JOINT AMENDMENT. **Decision Document/Options**Paper & Scoping Document completed by June 2009 meeting. A Scoping Document has been produced for use by the Gulf Council during their scoping process and an Options Paper has been prepared for the South Atlantic Council's Mackerel Committee & Council to use to develop specific actions for the Atlantic to be included in Amendment 18.
- 3. REQUEST CLARIFICATION ON THE COBIA ASSESSMENT. No SEDAR Cobia assessment is currently scheduled. The SEDAR Steering Committee is meeting in May and results will be included in the 2<sup>nd</sup> Briefing Book in the SEDAR Committee Tab.

#### B. Status of Work with Gulf Council on Amendment 18

The Gulf Council is Administrative Lead for the Coastal Migratory Pelagics Fishery Management Plan which means they are responsible for preparing the documents, etc. Rick Leard is the Gulf staff lead and Gregg Waugh is the South Atlantic staff lead. Rick will take the lead on developing Amendment 18 and Gregg will provide the input for South Atlantic Council actions; other SAFMC staff will provide input and analyses to Gregg for inclusion.

The SAFMC conducted scoping for mackerel changes as a part of scoping for the Comprehensive Annual Catch Limit (ACL) Amendment. The Gulf Council will approve a scoping document at their June 15-18, 2009 meeting in Tampa (Florida) and conduct scoping meetings after June; the SAFMC will approve this scoping document at their June 7-12, 2009 meeting in Stuart (Florida).

The Gulf and South Atlantic Councils, with input from the Mid-Atlantic Council through their two voting seats on the South Atlantic Council's mackerel committee, intend to complete the document so that the changes can be implemented during the 2011 fishing year. A timeline will be developed after the scoping process is completed.

#### C. GMFMC Scoping Document (Attachment 1)

Scoping meetings for the Comprehensive ACL Amendment were held January 26 – Feb 4, 2009 and comments were accepted through February 6, 2009. Scoping comments for the Comprehensive ACL Amendment addressing mackerel were presented to the Mackerel Committee during the March 2009 meeting.

The Gulf Council will conduct scoping meetings after their June 2009 meeting. Both Councils should will approve the scoping document for the Gulf scoping process at their June 2009 meetings.

#### D. Options Paper (Decision Document) (Attachment 2)

The options paper addresses items specific to the South Atlantic Council and includes decisions from the most recent review of the document by various groups (see cover for groups and dates reviewed). The South Atlantic Council's mackerel committee will review and revised these actions/alternatives at the June 9, 2009 meeting. The intent is to have all actions and a reasonable range of alternatives identified at the June 2009 meeting. These actions/alternatives will then be incorporated into the joint Mackerel Amendment 18 document. Our Mackerel AP will review and provide input during their August 18-19, 2009 meeting in Charleston, SC. A draft Amendment 18 document should be available for the September 2009 meeting.

A report on the FishSmart project is included as **Attachment 3** for the committee/Council's use in developing alternatives for Amendment 18.
