Mackerel Committee Meeting

March 1, 2010 Jekyll Island Club Jekyll Island, Georgia

The Mackerel Committee needs to: (A) receive a report on the Gulf Council's actions on the options paper for Joint Mackerel Amendment 18; (B) discuss the mackerel data request to the SEFSC and their response; (C) discuss the South Atlantic Council's participation in the Gulf Council's Mackerel LAPP work; and (D) discuss a request to allow use of float gear in the mackerel fishery.

A. Gulf Council's Actions on the Options Paper for Joint Mackerel Amendment 18

The Gulf Council and the South Atlantic Council are preparing a joint amendment to address the new requirements of the Reauthorized-MSA. Rick Leard and Gregg Waugh discussed the two staffs' workloads and proposed that Rick take the administrative lead for the Joint Mackerel Amendment and Gregg take the administrative lead for the Joint Spiny Lobster Amendment. The Gulf and South Atlantic Councils have approved this approach.

The South Atlantic Council has completed scoping as a part of the Comprehensive ACL Amendment scoping process. Scoping meetings were held as follows:

- (1) January 26, 2009 in Charleston, SC
- (2) January 27, 2009 in New Bern, NC
- (3) February 3, 2009 in Key Largo, FL
- (5) February 4, 2009 in Cape Canaveral, FL
- (5) February 5, 2009 in Pooler, GA

The Gulf Council held scoping meetings as shown below. Gregg Waugh, SAFMC Staff, attended the Key West and Marathon, Florida meetings.

- (1) September 21, 2009 in Key West, FL and Grand Isle, LA
- (2) September 22, 2009 in Marathon, FL; Biloxi, MS; and Corpus Christi, TX
- (3) September 23, 2009 in Madeira Beach, FL; Houston, TX; and Orange Beach, AL
- (4) September 24, 2009 in Panama City, FL

Gregg Waugh will review the draft Options Paper for Joint Mackerel Amendment 18 (Attachment 1) and the Gulf Council's actions (Attachment 2).

REQUIRED COMMITTEE ACTION:

- 1. Discuss the Gulf Council's actions on the Options Paper for Amendment 18. This version of the options paper does not have MSY, OY, MSST, MFMT, ABC and ABC Control Rule sections; this will be added after the Gulf Council meeting.
- 2. Provide guidance to staff as necessary

B. Mackerel Data Request

The South Atlantic Council's Scientific and Statistical Committee requested certain data for Atlantic Migratory Group King Mackerel to develop their ABC recommendation based on the control rule. A data request was sent to the SEFSC (Attachment 3). The SEFSC response will be included in the 2nd briefing book or provided by the SEFSC at the March 2010 Council meeting.

REQUIRED COMMITTEE ACTION:

- 1. Discuss the SEFSC's response.
- 2. Provide guidance to staff as necessary.

C. South Atlantic Council's Participation in Gulf Council's Mackerel LAPP

The Gulf Council is evaluating a LAPP for Gulf king mackerel. Such a program would impact fishermen on Florida's east coast. The South Atlantic Council needs to determine what level of participation is desired.

REQUIRED COMMITTEE ACTION:

- 1. Discuss the Gulf Council's actions for a LAPP. There will need to be some coordination for fishermen in Florida and the SAFMC needs to determine whether they are interested in exploring a LAPP for Atlantic Migratory Group King and/or Spanish Mackerel.
- 2. Provide guidance to staff as necessary

D. Request to Allow use of Float Gear in the Atlantic Migratory Group King Mackerel Fishery

The Council reviewed a previous request from Mr. Hickman (Brunswick County in North Carolina) at the September 2009 meeting. The request was to allow use of his float gear to catch king mackerel. The Council rejected this request largely because of the vertical lines as the float was tethered to an anchor and concern about threatened/endangered species. After the Council meeting, Mr. Hickman was told that the Council disapproved his request and why. Since then he has worked on some modifications to the gear including an option that would get rid of the vertical line. He wants to petition the Council once again and will be sending another letter and perhaps even a piece of gear to show what it is they are doing.

- 2. Provide guidance to staff as necessary
