Joint SA/GM Mackerel Committee Meeting

June 8, 2010 Renaissance Orlando Airport Hotel Orlando, Florida

The Joint Mackerel Committees need to: (A) receive a report on the Gulf & South Atlantic Councils' Scientific and Statistical Committees; (B) review actions in Coastal Migratory Pelagics (CMP) Amendment 18 and provide guidance to staff/team; (C) review actions in the SAFMC Actions document and provide guidance to staff/team; (D) discuss the potential King Mackerel Catch Share Program and provide guidance to staff/team; and (E) discuss public hearing dates/locations and provide guidance to staff.

Each Council's Committee will vote separately. George Geiger, SAFMC Mackerel Committee Chair, will conduct the voting for the South Atlantic Council's Committee, and Myron Fischer, GMFMC Mackerel Committee Chair, will conduct the voting for the Gulf Council's Committee. Recommendations from the SAFMC Mackerel Committee will be addressed by the South Atlantic Council during their Council meeting on June 11, 2010. The Gulf Council will consider their Mackerel Committee's recommendations during their June 14-16, 2010 Council meeting.

A. Gulf & South Atlantic Councils' SSC Reports

The South Atlantic Council's Scientific and Statistical Committee (SSC) has provided their recommendations on an ABC control rule and OFL/ABC values for Atlantic king and Spanish mackerel and cobia (**Attachment 1**). The Gulf Council's SSC has provided their recommendations for ACL and is currently considering ABC Control Rule recommendations. This material will be included in the 2nd Briefing Book if their recommendations are ready for Committee/Council action.

Dr. Carolyn Belcher will review the SAFMC SSC recommendations (**Attachment 1**) and the Gulf Council's SSC input will be reviewed by Rick Leard (**Attachment 2**). The Councils will address the SSC input as they make decisions for Mackerel Amendment 18.

B. Joint Mackerel (CMP) Amendment 18

The Gulf Council Committee and the South Atlantic Council Committee will review the first three actions in Mackerel Amendment 18 (**Attachment 3**). These are joint actions and must be approved by both Committees and both Councils.

Rick Leard, GMFMC Staff, will review **Action 1. Changes to the Fishery Management Unit** and **Action 2. Changes to the Framework.** The committees will discuss and vote on both of these actions.

Then, Gregg Waugh, SAFMC Staff, will review **Action 3. Consideration of Separate Gulf and Atlantic Migratory Groups of Cobia.** The committees will discuss and vote on this action.

Rich Leard will then review the actions that apply only to the Gulf Council. Only the Gulf Mackerel Committee will vote on these actions; these actions are up to the Gulf Council alone and do not require any action by the South Atlantic Council.

C. SAMFC Action Document for Amendment 18

Gregg Waugh, SAFMC Staff, will review actions that apply only to the South Atlantic Council (**Attachment 4**). Only the South Atlantic Mackerel Committee will vote on these actions; these actions are up to the South Atlantic Council alone and do not require any action by the Gulf Council.

D. South Atlantic Council's Participation in Gulf Council's Mackerel LAPP

The Gulf Council is evaluating a LAPP for Gulf king mackerel. Such a program would impact fishermen on Florida's east coast. Rick Leard, GMFMC Staff, will give an overview of the timing for this work.
