# B. Status of Commercial and Recreational Catches versus Quotas for King & Spanish Mackerel

The committee will receive briefings on the commercial catches versus quotas (**Attachment 1**) from the NMFS SERO and on the recreational catches (**Attachment 2**) versus quotas from the NMFS SEFSC. The committee will discuss the quota monitoring programs and take action as necessary.

#### C. Status of Mackerel Amendment 18/EA

NMFS SERO staff will provide a status report on Mackerel Amendment 18/EA. The Councils approved the amendment for formal review and implementation at their August meetings. The package was sent to NMFS on 9/26/11; the notice of availability published on 9/29/11 with the comment period ending on 11/28/11, and the proposed rule published on 10/24/11 with the comment period ending on 11/28/11. Amendment 18 was approved on December 15, 2011 and the Final Rule published on 12/29/11 with the regulations effective on 1/30/12.

### D. State by State Quotas

#### F. Scoping Document for Mackerel (CMP) Amendments 19 & 20

Gregg Waugh, SAFMC Staff, will review the scoping documents for Mackerel (CMP) Amendment 19 (Attachment 3b) and 20 (Attachment 4b). The South Atlantic Council provided guidance at the December 2011 meeting; these recommendations were included in the Gulf Council Briefing Book (Attachments 3a & 4a). The Gulf Council approved (Attachment 5) the South Atlantic changes, made some modifications, and approved the two documents for scoping at their January/February 2012 meeting. The Committee will develop recommendations on timing and locations for scoping these two amendments.

The Gulf Council is planning to scope Mackerel (CMP) Amendments 19 & 20 (and the Generic Dealer Amendment) at the following sites during the weeks of March 12<sup>th</sup> and March 19<sup>th</sup>:
