## **Mackerel Committee Meeting**

September 13, 2010 Charleston Marriott Hotel Charleston, SC

The Mackerel Committee need to: (A) approve minutes from the March 1<sup>st</sup> SAFMC Committee and the June 7<sup>th</sup> Joint Committee; (B) review previous council actions on Draft Mackerel Amendment 18/EA; and (C) review management measures/accountability measures necessary to ensure Atlantic king & Spanish mackerel and cobia ACLs are not exceeded and provide guidance to staff/team.

### **Previous Council Actions on Draft Mackerel Amendment 18/EA**

Gregg Waugh, SAFMC Staff, will provide an overview of actions from the June Joint Committee meeting (Attachment 1). The Gulf Council addressed the committee recommendations for joint and Gulf items and took action (Attachment 2). The South Atlantic Council addressed the joint items and some of the items for South Atlantic items (Attachment 3).

C. Joint Mackerel (CMP) Amendment 18/EA
The joint items and most of the other items in Mackerel Amendment 18/EA have been addressed; SAFMC separate actions shown in Attachment 4. The South Atlantic Committee and Council need to review the large number of actions/alternatives included as management measures for king & Spanish mackerel and Atlantic cobia and determine which management measures are to be used as accountability measures to ensure total mortality does not exceed our ACLs for king mackerel, Spanish mackerel, and cobia. The Mackerel IPT Team has recommended that the management measures be addressed in a future amendment. However, we need to ensure that sufficient regulations are in place to prevent the ACLs from being exceeded.

In **Attachment 4**, all management measures have been moved to Appendix B. The SAFMC Committee/Council will need to determine which of these items are included in Amendment 18 (e.g., modifications to bag limits, trip limits, etc.) and which are more complex and will require more time than is available for Amendment 18 and should be addressed in a future amendment (e.g., limited entry, etc.).
