#### Mackerel and Cobia Committee

## • Spanish Mackerel Management (SSC Report).

**Description**: At the March 2023 Council meeting, SSC Chair Dr. Jeff Buckel updated the Council on the January 2023 SSC meeting including the terms of reference developed by the Spanish mackerel workgroup and discussion of alternative methods of setting ABCs. The Council also discussed a letter from the Southeast Fisheries Science Center (SEFSC), stating that the revisions to SEDAR 78 requested by the SSC in January are exploratory in nature and require extensive rework. As such, they cannot be accomplished in a timely fashion. The Council again expressed the importance of receiving catch level recommendations at their June 2023 meeting. The SSC met again in April 2023, and Dr. Jeff Buckel will provide the Committee an update on SSC discussions relative to Spanish mackerel.

**Committee Action**: Direct staff to begin work on an amendment to adopt catch level recommendations from the SSC.

#### 1. Mackerel Advisory Panel Report (Attachment 1)

**Description**: The Mackerel Cobia Advisory Panel met on April 21<sup>st</sup>, 2023 via webinar. The AP Chair, Ira Laks, will provide a summary of Advisory Panel discussion and recommendations on items being discussed at this meeting as well as other items relevant to the Coastal Migratory Pelagics fishery.

Committee Action: review Advisory Panel input and provide guidance to staff.

# 2. Mackerel Port Meetings (Attachment 2).

**Description**: Based on recommendations from the Mackerel Cobia Advisory Panel, the Council directed staff to begin work on a plan to conduct port meetings for king and Spanish mackerel to gain a comprehensive understanding of the fisheries to improve management efforts. At the March 2023 meeting, the Council defined the focus of the port meetings, including focus species, topics, and outcomes. Council staff will present an updated planning document for Council review, including discussion of CMP FMP goals and objectives.

**Committee Action**: review port meetings proposal and provide direction to staff, as requested.

#### 3. King Mackerel Tournament Landings (*Attachment 3*).

**Description**: At their December 2022 meeting the Council requested NMFS provide information on king and Spanish mackerel tournament landings over the last ten years and how those landings were accounted for against the annual catch limit. The SEFSC has worked with the state agencies to provide these landings to the Council. Additionally, the SEFSC will provide an update on ACCSP technical committee discussions related to tracking tournament landings.

Committee Action: review landings and provide direction to staff.

#### 4. Topics for the Spring Mackerel Cobia Advisory Panel Meeting

**Description**: The Mackerel Cobia Advisory Panel is scheduled to meet this summer in Charleston, South Carolina.
