## **OVERVIEW** Mackerel and Cobia Committee

The Committee will approve minutes from March 2021 meeting and the agenda for the June 2021 Committee meeting.

- 3. Mackerel Cobia Advisory Panel Report (*Attachment 1*)
  Description: The Mackerel Cobia Advisory Panel met on April 6, 2021 via webinar. The AP Chair, Ira Laks, will provide a summary of Advisory Panel discussion and recommendations on amendments being discussed at this meeting as well as other items relevant to the Coastal Migratory Pelagics fishery.
  Committee Action: provide guidance to staff.
- 1. CMP Amendment 34 Updates to king mackerel management based on SEDAR 38 Update 2020 – (*Attachment 2*)

**Description**: At the June 2020 meeting the Council directed staff to begin work on an options paper that would include consideration of sector allocations and catch level adjustments based on SSC recommendations and the recent stock assessment update. At the March 2021 meeting, the Council approved actions and alternatives to be included in CMP Amendment 34 for analysis. Scoping for the amendment was also held during the public comment period associated with the March 2021 Council meeting. Additionally, the Council direct staff to revise the alternatives under Action 3 (sector allocations) to consider various time periods. Council staff will review a decision document for CMP Amendment 34 with analyses and updated action/alternative language.

**Committee Action**: review draft document, select preferred alternatives, and consider approval for public hearings.

4. CMP Amendment 32 – Updates to Gulf cobia management based on the SEDAR 28 Update 2020 and the CMP Framework Procedure – (*Attachments 3a* and *3b*) Description: An update to SEDAR 28 assessment for Gulf cobia was completed in July 2020. The results indicate that Gulf cobia is undergoing overfishing, which puts the stock at risk of becoming overfished without management action. The Gulf SSC reviewed the results of the updated SEDAR 28 assessment and provided recommendations for new ABCs for Gulf cobia. At the March 2021 meeting, the Council reviewed actions and alternatives, selected preferred alternatives, and requested an additional action be added to the amendment to address sector allocations in the Florida east coast (FLEC) zone. The Gulf Council reviewed this amendment at their April meeting, modified their preferred alternatives and discussed the implications of proposed catch limits and in-season closures. Council staff will review a decision document and a draft updated draft document for CMP Amendment 32 with analyses and updated action/alternative language.
