The Committee approved minutes from the June 2019 meeting and the agenda.

**Status of Commercial Catches versus Quota for Species under ACLs**

The Committee received an update on commercial landings for Atlantic king mackerel, Atlantic Spanish mackerel and Florida east coast cobia from SERO staff.

DIRECTION TO STAFF TO INCLUDE EXPANDED LANDINGS IN FUTURE COMMERCIAL CATCH UPDATES AND TO NOT INCLUDE ATLANTIC COBIA LANDINGS IN FUTURE REPORTS.

**Status of Amendments Under Formal Review**

SERO staff briefed the Committee on the status of CMP Framework 6. The proposed rule published on March 26, 2019 and comments the final rule published on September 10, 2019 with an effective date of September 11, 2019. The request for emergency action for the commercial king mackerel fishery was sent to NMFS on June 21, 2019, the document is currently up at NOAA Headquarters.

**CMP Framework Amendment 8 (king mackerel commercial trip limits during season two)**

At the June 2019 meeting, the Council requested NMFS take emergency action to increase in the commercial trip limit from 50-fish to 75-fish in the Atlantic southern zone, south of the Flagler/Volusia County line, Florida during season two of the 2019/2020 commercial fishing year. Framework Amendment 8 will permanently address season two commercial king mackerel trip limits. Staff presented a draft public hearing document for the Council to consider.

DIRECTION TO STAFF TO UPDATE THE DOCUMENT TO REFLECT SHIFTING BOUNDARIES BETWEEN THE GULF AND ATLANTIC STOCKS OF KING MACKEREL AND ASSOCIATED TRIP LIMITS PRIOR TO CMP AMENDMENT 26.

The following motions were passed by the Committee:

**MOTION #1:** ACCEPT THE IPT'S RECOMMENDED CHANGES TO THE PURPOSE AND NEED STATEMENT.

The *purpose* is to **modify increase** the commercial trip limit for Atlantic king mackerel in the Atlantic Southern Zone during Season 2 (October 1 to the end of February).

The *need* is to provide a commercial trip limit sufficient to support fishing activity and revenue opportunity while constraining harvest to the annual catch limit and providing for year-round access.

**MOTION #2:** ACCEPT THE IPT'S RECOMMENDED CHANGES TO THE ACTION/ALTERNATIVES LANGUAGE, REMOVING REFERENCE TO SEASON 1

**Alternative 1 (No Action):** The commercial trip limits for Atlantic king mackerel in Season 2 south of the Flagler/Volusia line (29°25'N) to the Miami-Dade/Monroe line (25°20'24"N) are:

### **Spanish Mackerel White Paper**

During the June 2019 meeting the Council directed staff to prepare a white paper with a thorough analysis of effort in the commercial Spanish mackerel fishery and a discussion of possible avenues to control effort, including: a limited access commercial permit, a limited access gillnet endorsement in the southern zone, and collaboration with state agencies. Staff presented the results contained in the white paper for discussion.

The following motions were passed by the Committee:

### **Port Meetings for King and Spanish Mackerel**

During the June 2019 meeting the Council reviewed a request from the Mackerel Cobia Advisory Panel to conduct port meetings to gain a comprehensive understanding of the commercial and recreational king and Spanish mackerel fisheries. The Council requested staff discussion of port meetings to be added to the September agenda. Staff presented information to guide discussion of the who, what, when, where, and why of port meetings.

The Committee discussed holding port meetings after the completion of stock assessments for king mackerel (update) and Spanish mackerel. In the interim states could engage with stakeholders to get more information on the mackerel fisheries.

**DIRECT STAFF TO POSTPONE WORK ON PORT MEETINGS UNTIL AFTER THE SPANISH MACKEREL STOCK ASSESSMENT.**

### **Gulf Framework Action to Modify Federal For-Hire Trip Limits**

At their August 2019 meeting, the Gulf Council reviewed options to modify the possession limits for anglers on for-hire vessels on trips exceeding 24 hours in duration. Presently, anglers on these trips may possess two daily bag limits for species managed under the Reef Fish and Coastal Migratory Pelagics FMPs; however, the second daily bag limit may not be possessed until after 24 hours have elapsed. Gulf Council staff updated the Committee on the development of the amendment. The Committee will revisit this issue next time a full CMP or Snapper Grouper amendment is discussed.
