OVERVIEW Mackerel Cobia Advisory Panel Meeting

The Committee will approve minutes from April 2023 meeting and the agenda.

 Update on recently submitted amendments (*Attachment 1a-1c*) Discussion: Staff will provide an update on recently submitted amendments relevant to the Coastal Migratory Pelagics Fishery Management Plan. Advisory Panel Action: None.

2. Citizen Science Update (*Attachment 2*)

Discussion: Council staff will provide information on Citizen Science Program activities. Updates will be given on the Citizen Science Program advisory groups, the Citizen Science Program's Project Idea Portal, Program evaluation and the SMILE and SAFMC Release projects. Additionally, staff will share information on the efforts underway to collect additional historic fishing photos for the FISHstory project. **Advisory Panel Action:** Discuss and provide input, as appropriate.

3. 'What It Means to Me' Outreach Project (Attachments 3a and 3b)

Discussion: Council staff will present recent updates on Best Fishing Practices outreach, including details on "What It Means to Me," a recently approved outreach initiative.

Advisory Panel Action: Discuss and provide input, as appropriate.

4. CMP FMP Framework Amendment 13: Atlantic Spanish Mackerel Catch Levels (*Attachment 4*)

Discussion: The SSC met in April 2023 and determined that the stock assessment for Atlantic Spanish mackerel (SEDAR 78) was sufficient for providing stock status and for providing catch level recommendations using model output (but not projections). In June 2023, the SSC chair provided the Council details of the SSC discussion and associated catch level recommendations. The Council directed staff to begin work on a framework amendment to update catch levels, but to hold off on development of a full plan amendment to address management measures until after mackerel port meetings have been completed. Council Staff will present a discussion document with draft actions and alternatives for AP discussion.

Advisory Panel Action: Review the discussion document and provide input on the action being considered.

5. Mackerel Port Meetings Planning Update (Attachments 5a and 5b)

Discussion: Based on recommendations from the Mackerel Cobia Advisory Panel, the Council directed staff to begin work on a plan to conduct port meetings for king and Spanish mackerel to gain a comprehensive understanding of the fisheries to improve management efforts. At the June 2023 meeting, the Council discussed goals and objectives for port meetings and approved the development of a planning team. Staff with provide the AP with an update on recent discussions and next steps, including draft meeting structure and locations.

Advisory Panel Action: Provide input on the proposed port meeting structure and possible meeting locations.

6. Wind Energy Activities in the Southeast Region (*Attachment 6*) Discussion: At the request of the Council, the AP will receive a presentation intended to provide information about offshore wind development in the South Atlantic region Advisory Panel Action: None.

7. King and Spanish Mackerel Fishing Tournaments (Attachment 7)

Discussion: At their December 2022 meeting the Council requested NMFS provide information on king and Spanish mackerel tournament landings over the last ten years and how those landings were accounted for against the annual catch limit. The SEFSC worked with the state agencies to provide these landings to the Council at their June 2023 meeting. The Council requested this information also go to the AP for discussion. **Advisory Panel Action**: Provide input on the role king and Spanish mackerel tournaments play in the coastal migratory pelagics fishery.

8. Atlantic King Mackerel Fishery Performance Report (Attachment 8)

Discussion: With input from the AP, Fishery Performance Reports (FPRs) have been developed for all Atlantic king mackerel, Atlantic Spanish mackerel, and Florida East Coast Zone Gulf cobia. The intent of the FPRs is to assemble information from AP members' experience and observations on the water and in the marketplace to complement scientific and landings data. The FPRs will be provided to the SSC, the Socio-Economic Panel (SEP), and the Council to assist in their discussions. Recently, the Council has received public input expressing concerns about the Atlantic king mackerel stock. In response, the Council has requested the AP update their FPR for Atlantic king mackerel.

Advisory Panel Action: Complete an updated Fishery Performance Report for Atlantic king mackerel.
