

PATROL ACTIVITY HIGHLIGHTS:

- 1. The FL FWCC Patrol Vessel *C.T. Randall* patrolled a total of 31 hours this quarter and boarded one recreational vessel inside the OHAPC with no violations. The *Randall* was deployed to St. Augustine, FL in December for a multi-day red snapper closure operation.
- 2. USCG small boats, patrol boats, major cutters, and UAV conducted a total of 36 hours of patrol within the OHAPC during this quarter.
- 3. SA Chesler conducted joint patrols with USCG Station Fort Pierce in November and December. Two recreational anglers were issued warnings for targeting HMS species without a permit.
