2. Approval of Minutes

The Committee last met March 2008.

3. SSC Selection

The Committee considered SSC appointments at the last meeting in March 2008, reappointed some previous members, invited some new applicants to join, and instructed staff to hold an orientation for all members.

All those invited to join the SSC accepted the invitation. An updated SSC roster is provided (**Attachment 1**).

SSC member orientation was held April 29-30 in Charleston. Seven of eight newly appointed members attended, and 3 of eight reappointed members attended. Most of those who did not attend were university employees with teaching obligations whose schedules could not accommodate the necessary short notice for the meeting. Informal feedback from attendees indicates the time and expense was well spent, as they greatly appreciated briefings on SSC member responsibilities, administrative items, SAFMC staff responsibilities, and ongoing issues. The orientation agenda is provided (**Attachment 2**) to show the issues that were addressed.

4. Council Technical Committees

At the September 2007 meeting the SSC Selection Committee approved reviving the Council FMP-based assessment committees, which led to staff preparing a detailed proposal addressing duties and possible membership that the Committee approved in December 2007 (**Attachment 3**). Council representatives were asked to consider potential members following the December 2007 and March 2008 meetings.

The committee is asked to appoint members to the technical committees at this meeting.

No former SSC members expressed interest in serving on technical committees.

One applicant who was not chosen for the SSC in March, Dr. Gene Wilde of Texas Tech University, has expressed interest in serving on a technical committee. Staff will contact Dr. Wilde prior to the meeting and report on his level of interest at the meeting.

Some current SSC members are interested in serving on technical committees. Staff will solicit SSC volunteers at the SSC meeting and report the results to this committee at the meeting.
