SUMMARY REPORT FROM THE SAFMC SEDAR COMMITTEE Charleston, SC September 13, 2011

The SAFMC SEDAR Committee met September 13th, 2011 at Charleston, SC. The Committee discussed the following items:

1. SEDAR Activities Update

The Committee was updated on progress on SEDAR 25, South Atlantic black sea bass and tilefish.

2. SEDAR Process Update

John Carmichael gave a presentation on SEDAR procedural changes implemented over the last several years.

3. SEFSC Data Program Update

Dr. Steve Turner of the Southeast Fisheries Science Center gave a presentation on data program improvements at the Center. This presentation was given on the morning of the 14th.

4. Incorporating Observer Comments

The Committee endorsed the proposed process for incorporating the comments and observations of SAFMC-appointed observers to SEDAR workshops.

5. Review SAFE Report Framework

The Committee reviewed a draft SAFE report for Snapper-Grouper and provided comments to staff. Report content and approach was acceptable, and staff was requested to keep such reports up-to-date in the future.

6. SEDAR Steering Committee Recommendations

The Committee prioritized stocks for assessment in 2013. Members were advised to forward any procedural concerns or suggestions to the Steering Committee representatives prior to the next meeting, which will be held October 13, 2011.

1) Red Snapper Benchmark

NOTE: request that SEFSC review independent monitoring program data on red snapper and report to the Committee, in December 2011 and March 2012, on

program findings and the prognosis for developing an informative assessment in 2013.

- 2) Blueline Tilefish Benchmark
- 3) Red Grouper Update or Standard

NOTE: Request review of red grouper data and bio-sample progress by SEFSC, and consideration of update or standard assessment by SEFSC and SSC.

4) Snowy Grouper Standard

5) Gag Grouper Standard

Alternates, if one of the above should prove infeasible or an additional assessment slot become available:

gray trigger, white grunt, scamp

7. SEDAR 28 Approvals

The Committee approved the schedule and Terms of Reference for SEDAR 28. The following bullet was added to DW TOR 4 for both Spanish mackerel and cobia:

"provide a single table showing landings by sector in whole weight, using the methods developed by SEFSC for ACL tracking to estimate recreational landings by weight"
