SUMMARY REPORT FROM THE SEDAR COMMITTEE Charleston SC

September 10th, 2012

The Committee received reports on current SEDAR activities and the SSCs progress in adapting the ORCS approach for developing OFL and ABC recommendations.

The Committee reviewed the modified assessment plan for 2013 and provided guidance for the Steering Committee representatives on priorities for 2014 and beyond. Table 1 summarizes short-term future assessment priorities for consideration at the Steering Committee.

Impediments to conducting a black sea bass update for review by the SSC in April 2013 were discussed. MARMAP may need assistance to ensure all otolith samples are processed and survey CPUEs prepared by early 2013. North Carolina and Florida offered to provide assistance. The Council reiterated its desire to receive updated black sea bass results at the June 2013 meeting.
