#### 4. <u>SEDAR ACTIVITIES UPDATE</u>

There have been no changes in SAFMC SEDAR activities since the last meeting in December. Table 1 provides an overview of upcoming assessment projects.

SEDAR staff is currently developing the comprehensive workshop schedule for 2016. When complete this will be reviewed by the Steering Committee.

SEDAR is organizing a procedures workshop devoted to data best practices, as directed by the Steering Committee, to be held June 15-19, 2015. The goal is to provide and document best practices for routine data issues and decisions.

The final report from MRIP Calibration Workshop II is expected to be available around the time of this meeting. This workshop, held in September 2014, considered calibration methods to address changes in the access point interview component.

Staff will brief the Committee on the ongoing work of the MRIP transition team to develop a plan for addressing changes in the effort interview component of the survey.

#### 5. <u>SEFSC UPDATE</u>

The Center will provide updates on several projects the Committee has been monitoring: Headboat Data Evaluation and SEFSC Assessment Program Review. Attachment 3 is the report of the assessment program peer review panel and **attachment 4** is the SEFSC response to the panel.

The Center is also asked to provide a report on assessment capacity for 2017 and 2018, to assist the Committee in developing its SEDAR assessment project request. The next step in 2017 and beyond planning, SSC recommendations for priority stocks, will be addressed at the April 2015 SSC meeting. SSC recommendations will be provided to this Committee in June 2015, to be considered when developing the request for Steering Committee consideration in October 2015.
