



## **Background**

- S Atlantic Greater
   Amberjack assessed
   earlier in 2020 (SEDAR 59) (Fig. 1)
  - Not overfished
  - Not experiencing overfishing
- FES recreational estimates
- Projections for 2020-2024





#### **SSC Recommendations**

- SSC reviewed SEDAR 59 in April 2020
  - Recommended OFLs and ABCs through 2024 (Table 1)
  - Current ABC = 1,968,000 lbs ww

### Management Issues/Questions

- Current ABC, total and sector ACLs, sector allocation percentages, and recreational ACT based on MRFSS recreational data
- MRIP will use FES moving forward
- Does the Council want to update management numeric values to reflect the new assessment and recreational estimation methodology?
  - Current values are as/more conservative
- Does the Council want to make other changes to management of S Atlantic Greater Amberjack?



# **Potential Amendment Timing**

Dates	Process Steps
December 2020	Review options paper and provide guidance to staff
March 2021	Review draft amendment and approve for scoping
Apr-May 2021	Conduct scoping hearings
June 2021	Review scoping comments, review preliminary analyses, and provide guidance to staff
September 2021	Review modifications to the amendment, select preferred alternatives, and approve for public hearings
Oct-Nov 2021	Conduct public hearings
December 2021	Review public comment and approve all actions
March 2022	Review final draft amendment and consider approval for formal review
Mid to late 2022	Regulations effective



#### **Action 1 – Total ACL and OY**

- ABC = OY = Total ACL = 1,968,000 lbs ww
- Alternatives include Total ACL =
  - 1. Current value
  - 2. SSC-recommended ABC

- 3. 90% SSC-recommended ABC
- 4. 80% SSC-recommended ABC



#### **Action 1 - Total ACL and OY**

- Projections beyond 2024 will be requested (management likely to be effective in 2022-23 fishing year)
- Modify OY separate from ACL?
- Guidance on unit?
  - lbs ww, lbs gw, or numbers of fish used in different parts of management
  - Conversions available
  - Projections and ABC recommendations in lbs ww and numbers of fish



#### Action 2 - Sector Allocations

- Current formula:
  - weighted average of com/rec landings over total landings
  - **-** 50% 1986-2008, 50% 2006-2008
  - MRFSS recreational data
- Commercial: 40.66% (800,163 lbs ww)
- Recreational: 59.34% (1,167,837 lbs ww)



#### **Action 2 - Sector Allocations**

#### Alternatives:

- 1. Current formula and values (1986-2008 MRFSS estimates) (Framework)
- Current formula and updated values (1986-2008 FES estimates); C: 29.85%, R: 70.15%
   (Framework)
- 3. Maintain commercial allocation poundage (800,163 lbs ww); C: 28-30%, R: 70-72% (Plan)
- 4. No sector allocations (Plan)



#### **Action 3 - Recreational ACT**

- Current ACT: 992,662 lbs ww
  - Based on current ACL and MRFSS data through
     2008
  - Uses average of PSEs from the last 5 years (when previously applied, 2005-2009)
- ACT not currently used in Accountability Measures



#### **Action 3 - Recreational ACT**

- Alternatives (Framework):
  - 1. Current formula and value (Current ACL and PSEs from 2005-2009)
  - 2. Current formula and updated values (ACL from Actions 1 and 2 and PSEs from 2015-2019)
