5. Regulatory Amendment 15 (Management measures for yellowtail snapper and groupers; *Attachment 2*)

This amendment would adjust the yellowtail ABC, ACLs, and ACT based on the new stock assessment. The Emergency Rule would implement the adjustment for 180 days but an amendment is needed to make a longer-term change in the regulations. This amendment would also modify the yellowtail fishing year, establish a spawning season closure for yellowtail, and address the shallow-water grouper closure when the gag commercial ACL is met or projected to be met.

- 6. Regulatory Amendment 13 (MRIP adjustments for unassessed snapper grouper species; *Attachments 3a & 3b*)

This amendment would make the ACLs comparable to the landings estimates based on MRIP methodology and review/update recreational and commercial data. An Environmental Assessment is needed to make this adjustment because the change in recreational landings estimates will shift the commercial/recreational allocation based on the Council's current allocation formula (Boyle's Law).

- 7. Amendment 28 (regulations to allow limited harvest of red snapper; *Attachment 4*)

  This amendment would put in place measures to allow limited commercial and recreational harvest of red snapper in 2013 and beyond. The 2012 opening was accomplished through a Temporary Rule via Emergency Action. These measures will expire before summer 2013, when an opening for red snapper harvest would be most likely to take place. Therefore, the Council is developing Amendment 28 to establish a process to re-open the fishery.
