SUMMARY REPORT SNAPPER GROUPER COMMITTEE SOUTH ATLANTIC FISHERY MANAGEMENT COUNCIL

Jekyll Island, GA March 5-9, 2018

The Committee approved minutes from the December 2017 meeting and the agenda.

Status of Commercial & Recreational Catches versus Quotas for Species under ACLs NMFS Southeast Regional Office (SERO) staff delivered briefings to the Committee on the status of commercial landings relative to ACLs.

Status of Amendments under Formal Review

SERO staff updated the Committee on the status amendments currently under review:

- Amendment 41 (mutton snapper): became effective on February 10, 2018.
- Golden tilefish interim rule: Became effective on January 2, 2018 but will expire in June with the possibility of renewal for an additional 186 days.
- Amendment 43 (red snapper): Proposed rule and Notice of Availability due soon.
- Abbreviated Framework Amendment 1 (Red Grouper): Proposed rule

Amendment 46 (recreational reporting and best fishing practices)

The Committee made no changes to the Purpose and Need of the amendment but discussed the focus of the proposed permit for private recreational fishermen. Staff clarified that staff from the Marine Recreational Information Program (MRIP) have been invited to participate in the IPT for this amendment. The Committee provided guidance and made the following motions:

MOTION #1: APPROVE INCLUSION OF ACTION 1 IN AMENDMENT 46 AND APPROVE THE RANGE OF ALTERNATIVES UNDER ACTION 1 FOR DETAILED ANALYSIS.

Action 1. Establish a Private Recreational Snapper Grouper Permit Recreational Fishermen to Fish For, Harvest or Possess Snapper Grouper Species in the South Atlantic Region.

Alternative 1 (No Action). Recreational snapper grouper fishing from private recreational vessels in federal waters is an open access fishery with no federal requirement for a recreational permit.

Alternative 2. Require a federal recreational permit in the South Atlantic Region (federal waters only) for recreational fishermen to fish for, harvest, or possess: **Sub-alternative 2a.** red snapper.

Sub-alternative 2b. all species in the snapper grouper fishery management unit. **Sub-alternative 2c.** species in the deep-water snapper grouper complex.

Alternative 3. Require a federal recreational permit in the South Atlantic Region be issued to:

Sub-alternative 3a. vessel. **Sub-alternative 3b.** individual.

Alternative 4. Establish conditions to renew or maintain a valid permit.

Guidance on Action: 1

- Include pros and cons of federal permit vs. permit issued through the states
- Remove questions #7 & 8 regarding limited access
- Include pros and cons of making the proposed permit compatible with MRIP

- Include discussion of how no fishing reports would be handled

MOTION #2: APPROVE INCLUSION OF ACTION 2 IN AMENDMENT 46 AND APPROVE THE RANGE OF ALTERNATIVES UNDER ACTION 2 FOR DETAILED ANALYSIS.

Action 2. Modify Reporting Requirements for Private Recreational Fishermen or Vessels.

Alternative 1 (No Action). There is no reporting requirement for recreational anglers although the Council approved an action which would require owner or operator to complete fishing records if selected by the Science and Research Director (SAFMC 2008).

Alternative 2. Require private recreational anglers to complete electronic logbooks. This would require selected (Council to specify %selected based on SSC and other technical input) fishermen with a recreational snapper grouper permit to report electronically each week when fishing for or catching species listed in the Action 1

Alternative 3. Promote voluntary electronic reporting by private recreational fishermen. APPROVED BY COMMITTEE APPROVED BY COUNCIL.

Guidance on Action 2:

- Restructure alternative 2 to reflect how Action 1 is structured, with options for vessel and individual fishermen
- Provide alternatives for frequency of reporting (weekly & monthly)
- Include pros and cons of individual vs. vessel reporting under Action 2

MOTION #3: REMOVE ACTIONS 3 AND 4 FROM AMENDMENT 46 AND CREATE A SEPARATE AMENDMENT (FRAMEWORK).

Action 3. Require Use of Best Fishing Practices When Fishing for Snapper Grouper Species With Hook-and-Line Gear to Reduce Mortality and Bycatch of Snapper Grouper Species

Action 4. Adjust Powerhead Prohibitions in the South Atlantic Region APPROVED BY COMMITTEE APPROVED BY COUNCIL

Guidance on Actions 3 & 4:

• Concern over enforceability of circle hook alternatives and level of controversy of proposed measures under this action.

- Guidance to include language on "approved" descending devices and define what that means.
- Best fishing practices could be encouraged through education/outreach rather than regulation
- Consider removing Actions 3 & 4 and create another amendment that could move more quickly. Actions 1 & 2 could potentially cause delay/controversy of actions for best fishing practices and powerhead regulations.
- Consider requiring "as needed" to facilitate enforcement similar to current regulations on dehooking devices.
- For Alternative 4 under Action 3, look at language used/proposed in Gulf measures to promote consistency.
- Include alternative to have circle hooks on board. This would address the fact that circle hooks are not appropriate for certain species.
- Remove Sub-alternative 4c as it is not enforceable.
- Add an alternative that addresses "no more than one leader"

Vision Blueprint Regulatory Amendment 26 (Recreational)

Staff delivered a presentation to recap recent actions the Council took on the amendment in December 2017 and point out recommendation from staff/IPT, etc. The Committee provided guidance and made the following motions:

MOTION #4: SELECT ALTERNATIVE 2 UNDER ACTION 1 AS PREFERRED

Alternative 2. Modify existing Snapper Grouper aggregates to establish a Deep-water Species Aggregate, Shallow-water Grouper Aggregate, and Other Shallow-water Species Aggregate.

Deep-water Species Aggregate: queen snapper, blackfin snapper, silk snapper, snowy grouper, misty grouper, yellowedge grouper, blueline tilefish, golden tilefish, wreckfish **Shallow-water Grouper Aggregate**: gag, black grouper, red grouper, scamp, yellowfin grouper, yellowmouth grouper, red hind, rock hind, graysby, and coney.

Other Shallow-water Species Aggregate: whitebone porgy, jolthead porgy, knobbed porgy, saucereye porgy, scup, almaco jack, banded rudderfish, lesser amberjack, white grunt, margate, sailor's choice, tomtate, Atlantic spadefish, gray triggerfish, bar jack, lane snapper, yellowtail snapper, gray snapper, mutton snapper, cubera snapper, and sand tilefish.

Sub-alternative 2a. Include black sea bass, vermilion snapper, greater amberjack, hogfish, and red porgy in the Other Shallow-Water Species Aggregate **Sub-alternative 2b.** Exclude black sea bass, vermilion snapper, greater amberjack, hogfish, and red porgy from the Other Shallow-Water Species Aggregate

Sub-alternative 2b. May 1 through August 31 January 1 to April 30 and September 1 to December 31 (8 months)

- Clarify why there are predicted reductions for snowy and blueline tilefish under Subalternative 2b, which reflects current recreational season for those species.
- Include discussion of goal/intent of this action in discussion.
- Include additional explanation under Alternative 1 that that was the estimated harvest for those years.
- Include additional language regarding the paucity of information and high level of uncertainty in analyses.
- Adopt suggested edits as modified.

Improving Recreational Estimates

Staff delivered a presentation summarizing the issues with recreational estimates in the South Atlantic region and the Council's options to work towards improving those estimates or adopting management approaches that minimize the effects of uncertain estimates on stakeholders (i.e., inseason closures).

Dr. Crabtree, NMFS Southeast Region Administrator, updated the Committee on the status of the For-Hire Electronic Reporting Amendment:

- Proposed Rule and Notice of Availability for the amendment are at headquarters.
- The SEFSC feels that the effort information expected to result from implementation of electronic reporting for charter vessels in the South Atlantic could be used to improve effort estimates (similar to the VTR system in the Mid-Atlantic). However, the data would not be immediately used to improve catch estimates since this would first require certification through the MRIP program and a system to validate those data.
- Data validation will be costly and SERO is looking for funding to accomplish this in the future
- Proposed system for charter boats is similar to headboat survey, where there are six employees running the program for less than 200 vessels. NMFS would need to increase staff significantly for the proposed charter vessel reporting program to be as efficient as the headboat survey.
- NMFS may propose the Council consider a hail-out provision, some type of vessel
 positioning system, and adoption of a limited entry program for federally permitted
 charter vessels to assist with penalties for lack of reporting. Also, timing of trip report
 (submitting prior to offloading) would facilitate process and aid in validation of catch
 reporting.
- Once it is more definite what validation will take, NMFS would come back to the Council with ways that the system would need to be modified to obtain MRIP certification, etc.

Socio-economic Profile of the South Atlantic Snapper Grouper Commercial Fishery

Dr. Kari MacLauchlin, former Council staff, delivered a presentation on the draft profile and answered questions from Committee members. The Committee made a few suggestions of items to include/clarify. The report will be presented to the Snapper Grouper AP during their upcoming meeting (April 11-13, 2018) and will be revised based on the AP's input.

Vision Blueprint Regulatory Amendment 27 (Commercial)

Council staff delivered a presentation to recap guidance provided during the December 2017 meeting, review timing, and objectives for this meeting. The Committee provided guidance and made the following motions:

Snapper Grouper For-Hire Permit Moratorium

Council staff presented an options paper and requested guidance from the Committee. Committee members offered the following comments:

- Moratorium, by definition, is a temporary halting of some action, so there is no need to include a sunset provision. Limited entry is more permanent. Consider removing the word "moratorium" if the Council does not want to consider this option.
- Reporting compliance is not necessarily tied to a limited entry program; there are other ways to ensure compliance. Also, there is no reporting requirement currently in place, so it is premature to claim that there is a problem with logbook reporting compliance.
- Limiting entry is important in achieving compliance for logbook reporting.
- An important issue is the regulation that prevents charter vessels with a federal permit from possessing species that are open to harvest in state waters but closed to harvest in federal waters. The Council could re-visit this regulation during scoping.
- The Council needs to address issue of vessels operating without proper federal permits; this is a law enforcement issue that may not be solved with a permit moratorium.
- Consider tying permits to the vessel owner/operator, not to the vessel for enforcement purposes.
- Concern that a permit moratorium may complicate outreach for and implementation of the reporting requirement for charter vessels.
- Clarify why the Council is considering a for-hire permit moratorium.
- The Committee recommends that the entire range of options be taken out for scoping to get comments.
- Discussion questions need to be included in the scoping document.
- Guidance to produce a scoping document that includes the issues raised during the discussion.

Items that will be added to the scoping document:

- Expand and improve need for amendment:
 - o Add more background information

- o Further develop bullet points under "Why is the Council Considering Action?", paying extra attention to "logbook reporting compliance", "professionalizing the for-hire fleet", "situations of vessel overcapacity", "reducing fishing pressure on some fish stocks", and "stabilizing participation in the for-hire fishery, during which time the Council could evaluate the need for establishing limited entry".
- Include statement in scoping document that clarifies that the Council is considering a moratorium in order to evaluate whether a limited entry system or other modifications to how the for-hire fleet is managed or operates are desirable.
- Ways to address the regulation that prevents charter vessels with a federal permit from
 possessing species that are open to harvest in state waters but closed to harvest in federal
 waters.
- An option to tie a for-hire permit to a person or entity rather than a vessel.
- Under "New Entrants Permit" change "would" to "could" in description and add question to get input on how many "New Entrants Permits" should be made available each year.
- Clarify that the USCG inspection is referring to the voluntary program.
- Include requirements of MSA and National Standard Guidelines in scoping document.
- Include question asking for a desirable length of a moratorium (how many years).
- Research and add information on other moratoriums that have been implemented.

<u>NOTE</u>: It is the understanding of staff that no sections or subjects included in the options paper presented during Committee will be removed before scoping occurs.

Red grouper Rebuilding

Staff reviewed a possible timing to revise the rebuilding pan for red grouper. A rebuilding plan needs to be in place by September 2019, so it will not include data resulting from the MRIP revisions.

Regulatory Amendment 28 (Golden Tilefish)

Council staff provided some background on the need and timing of this amendment. The golden tilefish stock is undergoing overfishing and a temporary rule set the ACL for 2018 to reduce overfishing. The rule will expire at the end of 2018 (once it is extended) so the Council must have an amendment in place by the beginning of 2019. To accomplish this, an amendment must

be prepared and submitted for formal review by summer of 2018. The amendment would establish ACLs based on results of the SEDAR 25 update (2016) and the SSC's recommended ABC. The Committee made the following motions:

MOTION #28: APPROVE THE RANGE OF ALTERNATIVES UNER ACTION 1 AS MODIFIED.

Action 1: Revise the Annual Catch Limits for Golden Tilefish

Alternative 1 (No Action). The total annual catch limit for golden tilefish is equal to the yield at 75% of F_{MSY} when the population is at equilibrium. The current total annual catch limit for golden tilefish is 323,000 pounds gutted weight, as established temporarily through an interim rule for golden tilefish implemented on January 2, 2017 (83 FR 65). The interim rule value is based on projected yield of 75% of F_{MSY}. This interim rule is valid through July 1, 2018 and may be extended for an additional 186 days. Once the interim rule expires, the ACL will revert back to the previous ACL of 558,036 pounds gutted weight.

Alternative 2. Revise the golden tilefish annual catch limits. The total annual catch limit would equal the acceptable biological catch. (The acceptable biological catch recommendation from the South Atlantic Fishery Management Council's Scientific and Statistical Committee is P*=30%.)

Alternative 3. Revise the golden tilefish annual catch limits. The total annual catch limit =90% of ABC. (The acceptable biological catch recommendation from the South Atlantic Fishery Management Council's Scientific and Statistical Committee is P*=30%.)

Alternative 4. Revise the golden tilefish annual catch limits. The total annual catch limit = 80% of ABC. (The acceptable biological catch recommendation from the South Atlantic Fishery Management Council's Scientific and Statistical Committee is P*=30%.) APPROVED BY COMMITTEE APPROVED BY COUNCIL

Wreckfish ITO Review

Council staff updated the Committee on the status of the review. The Committee offered the following guidance:

- Have the SSC, Law Enforcement AP and Snapper Grouper AP review the draft document at their Spring 2018 meetings.
- The Council does not want to see the document at the June 2018 meeting.
- Staff should begin planning to meet with the shareholders in late June, early July.
- Bring a complete document back to the Council in September 2018 for approval or further direction.

Yellowtail Snapper

Council staff re-capped discussions to-date on this topic. Committee members offered the following comments:

- In fall 2017, FWC staff conducted interviews with dealers (and some fishermen) to obtain input on yellowtail management.
- Stakeholders (mainly dealers) had various suggestions for various management measures although there was no consensus on one particular approach or measure.
- The Council could look at short-term option to provide immediate relief for fishermen (in light of hurricanes in summer 2017) via a framework amendment. Consider changing AMs to remove in-season closures for either sector until the total ACL is met or projected to be met.
- Long term management measures could include combining the ACLs for the Gulf and South Atlantic, specification of a trip limit after certain percentage of the ACL is met, reallocation between recreational and commercial sectors (after MRIP recalibration data are available).
- A coding error when the initial jurisdictional allocation of the ABC between the South Atlantic and the Gulf potentially resulted in less allocation of the yellowtail ABC to the South Atlantic and to the commercial sector. FWC can provide corrected numbers to SEFSC to consider correcting the jurisdictional and sector allocation.

Vision Blueprint Review Guidance

Staff re-capped the guidance for a biennial evaluation of the Vision Blueprint for the Snapper Grouper fishery and requested guidance from the Committee on the timing and approach. The Committee offered possibly holding webinars/listening stations in late summer 2018 (August) and in conjunction with the fall 2018 Snapper Grouper Advisory Panel meeting.

System Management Plan Review Guidance

Staff requested guidance for the development of the Spawning Special Management Zone System Management Plan Review to ensure the document best meets the Council's expectations. The Committee suggested that the review resemble the Channel Island 5 Year Review (option 3) with site descriptions. They also requested that the workgroup begin development of a report card that would be used by all groups.

Modifications to Sea Turtle Release Gear and Snapper Grouper Framework

- Suggestion to revise language to specify the permits that would be affected
- SERO clarified that the careful release protocol document is available electronically. NOAA GC further clarified that the protocol is indeed required to be on board.
- The Council requested staff begin developing the amendment and take it to scoping.

Other Business

Dr. Michelle Duval, Snapper Grouper Committee Chair, briefed the Committee on an issue that was brought to her attention by fishermen in North Carolina. It appears that conflicts among fishermen using spearfishing gear and those using hook-and-line gear to target snapper grouper species in certain areas off North Carolina is increasing. Dr. Duval stated some fishermen have suggested a possible endorsement program for spearfishing gear. The topic will be brought up before the Snapper Grouper AP for feedback during their upcoming meeting.

The topic of regional quotas was briefly discussed as a result of the motion below offered in response to concern over accessibility issues and the perception that current management approaches are not addressing the problem effectively. Council members who opposed the motion cited concerns over already small commercial quotas that would be split even further under a regional quota scenario and add complication to monitoring of ACLs, etc. In addition,

there was concern that such an allocation of commercial ACLs would be perceived as a precursor to a limited access privilege program.

Rationale for Revisiting ABC Recommendation for Golden Tilefish:

The Council is willing to accept the risk of overfishing associated with an ABC of 362,000 pounds (whole weight) for 2019 and 2020. This is the ABC level currently implemented through an emergency rule for 2018. The Council accepts the risk associated with this ABC level for the following reasons:

- The Council can accept a higher risk level. Based on prior discussions regarding ABC control rule modifications, both the Council and SSC agree that it is the Council's responsibility to set the accepted risk of overfishing. Revisions to the ABC control rule are currently under consideration by the Council that would allow the Council to specify the risk level, but such provision are not yet in effect.
- The SSC has the ability to deviate from the existing ABC control rule.
- This ABC level will only be in effect until the next assessment is completed. A standard assessment is planned for 2019 to address issues noted by the SSC with the previous update.
- The level of harvest proposed by the Council is in effect for 2018, and projections indicate it will result in a fishing mortality rate of 0.173, below the overfishing limit of Fmsy=0.24.
- This level of harvest represents a 42% reduction from the annual catch limit that was in effect prior to 2018, and was in effect during the 2012-2014 period that led to the stock assessment finding that overfishing was occurring (terminal F / Fmsy = 1.22)
- Current management actions successfully control the fishery to the ACL. From 2012 to 2017, cumulative commercial landings totaled 102% of the commercial ACL, and annual landings exceeded the ACL in only one of those 6 years.
- The P* approach applied to golden Tilefish has resulted in an unusually large difference between OFL and ABC, creating the largest buffer of any SAFMC stock. This unusual buffer has been acknowledged by the SEFSC and discussed by the SSC on previous occasions, and no clear explanation for it is available.
- The Council is concerned by the considerable social and economic impacts resulting from current ABC recommendation.
- The golden Tilefish fishery is primarily (97%) allocated to the commercial sector. The primary harvest occurs in a longline fishery which takes place over about 3 months from an opening on January 1 to a closure around mid-March when the its ACL is met.
