# SUMMARY REPORT SNAPPER GROUPER COMMITTEE SOUTH ATLANTIC FISHERY MANAGEMENT COUNCIL Jekyll Island, GA

March 4 -6, 2019

The Committee approved minutes from the December 2018 meeting and the agenda.

Status of Commercial & Recreational Catches versus Quotas for Species under ACLs NMFS Southeast Regional Office (SERO) staff delivered briefings to the Committee on the status of commercial landings relative to ACLs as of February 26, 2019.

#### **Status of Amendments under Formal Review**

SERO staff updated the Committee on the status amendments currently under review:

- Vision Blueprint Regulatory Amendment 27 was submitted for formal review on 1/24/19. Due to the partial government shutdown, review of this amendment was delayed. NMFS is working on the proposed rule package.
- Vision Blueprint Regulatory Amendment 26 the Council approved the amendment for formal review at their December 2018 meeting. Due to the partial government shutdown, the amendment has not yet been submitted but is under review by the Council chair.
- Abbreviated Framework 2 (black sea bass & vermilion snapper) the proposed rule for this amendment published on 2/19/19 and the comment period ended on March 6, 2019.

#### **Update on 2019 Red Snapper Season**

SERO staff briefed the Committee on the projected 2019 red snapper season. As implemented through Amendment 43, the commercial season begins each year on the second Monday in July and the recreational season begins on the second Friday in July. SERO has predicted that the recreational red snapper season in 2019, based on the catch rate in 2018 and the ACL established through Amendment 43, can be open for 5 days. Consequently, red snapper harvest in 2019 will be allowed on July 12, 13, and 14 (Friday, Saturday, Sunday) and on July 19 and 20, (Friday and Saturday). Commercial harvest of red snapper will open on July 8, 2019, and will close at 12:01 a.m., local time, on January 1, 2020, unless the commercial annual catch limit is met or projected to be met before this date. The Committee discussed possibly modifying the definition of "weekends" for the recreational sector to allow more flexibility in 2020 and future red snapper seasons in the South Atlantic.

\* For the purpose of this requirement, "descending device" means an instrument that will release fish at a depth sufficient for the fish to be able to recover from the effects of barotrauma, generally 33 feet (twice the atmospheric pressure at the surface) or greater. The device can be, BUT IS NOT LIMITED TO, a weighted hook, lip clamp, or box that will hold the fish while it is lowered to depth. The device should be capable of releasing the fish automatically, releasing the fish by actions of the operator of the device, or by allowing the fish to escape on its own. Since minimizing surface time is critical to increasing survival, descending devices should SHALL be rigged and ready for use while fishing is occurring.

### Amendment 42 (Sea Turtle Release Gear & Framework Modification)

The amendment proposes modifications to regulations for vessels with South Atlantic snapper grouper commercial or charter vessel headboat permits to allow the use of three additional sea turtle release gear types and to clarify dimension requirements for current sea turtle release gear. The amendment also proposes changes to the snapper grouper framework procedure to facilitate modifying sea turtle and other protected resources release gear and handling requirements in the future. Council and NOAA staff proposed including in this amendment objectives in the Snapper Grouper FMP as revised during the visioning process. The Committee reviewed a public hearing draft of Amendment 42 at the December 2018 Council meeting. The document was reformatted to expedite review once approved. Public comment was obtained during the March 2019 meeting. The Committee provided the following guidance:

#### Wreckfish ITQ Review

The Committee received an updated on the development of the Wreckfish ITQ Review report. While some work had been done since the December 2018 meeting, enough progress was not made due to the Federal government shutdown. The Council can expect to see a draft final document in June and then a final document for approval at the September meeting.

#### **NMFS SERO Permits Presentation**

The Council discussed this request at their October 2018 meeting and directed staff to request a presentation from the Southeast Region Permits Office to be delivered at the March 2019 Council meeting and the Spring 2019 AP meeting. The Council provided further guidance at their December 2018 meeting and the request was sent to SERO on 12/17/19. Kevin McIntosh, Acting Permits Branch Chief, delivered the presentation to the Committee. During the discussion, it was suggested that the Council could modify logbook compliance requirements. NOAA GC will work with staff to explore the possibility and bring that information back to the Committee.

#### **Results of Recreational Workshops**

Following the American Sportfishing Association (ASA) September 2018 workshop with the Council to discuss new ideas for management of the private recreational sector of the Snapper Grouper fishery, a series of regional meetings were coordinated by ASA to get input from local recreational representatives on angler preferences, harvest rate management, harvest tags for deep-water species, registration and reporting, and barotrauma reduction. Dr. Kari Buck, facilitator for the meetings, presented the outcome of the regional meetings. Final recommendations from the ASA workshops are listed below:

- The Council should consider regional regulations for appropriate species.
- The Council should continue to explore harvest rate management for high value snapper grouper species, especially for red snapper.
- The Council could consider an Exempted Fishing Permit for a pilot program to test harvest tags for certain deep-water species (i.e., those with low annual catch limits or low abundance).
- The Council should work with state partners to establish a registration for anglers targeting snapper grouper species, with consistency across all states.
- The Council should continue development of Snapper Grouper Amendment 46 to implement required or selective reporting for recreational anglers and continue outreach on benefits of providing data.
- The Council should continue development of Snapper Grouper Amendment 29 to require use of descending devices or venting tools, along with other best fishing practices, to reduce release mortality.

The Committee requested that results of this project be presented to the Snapper Grouper Advisory Panel at their Spring 2019 meeting and that the AP provide recommendations/perspective on the practicability of the suggested approaches for management of the recreational snapper grouper fishery.

### Spearfishing in the South Atlantic Snapper Grouper Fishery

The Snapper Grouper AP discussed spearfishing at their spring 2018 meeting and approved two motions to encourage the Council to characterize use of this gear in the commercial and recreational sectors of the snapper grouper fishery. At their October 2018 meeting, the AP approved another motion to recommend a gear endorsement for the commercial sector. The Council subsequently instructed staff to prepare a white paper to discuss the topic in March 2019. Council staff presented data on landings of snapper grouper species (combined and for select species) attributed to spearfishing gear in the commercial and recreational. The Committee requested that the white paper and presentation be delivered to the Snapper Grouper AP at their Spring 2019 meeting. A suggestion was made for each state to identify prominent commercial spearfishing participants and possibly bring them together via webinar to discuss the topic after the June 2019 meeting.

#### Agenda Items for April 2019 Snapper Grouper AP Meeting

Staff presented possible agenda items for the Spring 2019 meeting and obtained guidance from the Committee. The Committee approved the following list of items to include in the agenda:

- Fishery Performance Reports for blueline tilefish and scamp
- Input on ABC Control Rule Amendment (actions and alternatives; risk of overfishing categories for unassessed SG species)
- Input on Recreational Accountability Measures amendment
- Southeast Regional Office Permits Presentation
- Spearfishing in the Snapper Grouper Fishery provide recommendations for possible regulations
- Student presentation on effect of management measures on fishing rates for select species
- Recreational Workshops results presentation provide recommendations/perspective on practicability of suggested approaches
- Review descending device definition in Am 29 and provide input
- Input on current Snapper Grouper Fishery Management Plan objectives
- Citizen Science update and AP recommendations

### **Vision Blueprint Outreach**

The 2016-2020 Vision Blueprint for the Snapper Grouper Fishery was approved in December 2015 and includes prioritized short-term objectives around broad goals addressing science, management, communication, and governance. In December 2018, the Committee provided guidance to assist in developing next steps. Staff presented outreach material that includes an overview of the actions left to address in the Vision Blueprint. The Committee opted not to request direct stakeholder input on the Vision Blueprint at this time, noting that stakeholders are encouraged to provide their input to the Council at any time. The Committee requested that the Snapper Grouper Advisory Panel provide feedback on the current objectives in the Snapper Grouper FMP at their Spring 2019 meeting.

#### **Spawning Special Management Zone Update**

The System Management Plan Workgroup has been drafting sections for an outreach document/webpage on the Spawning Special Management Zones recommended in Amendment 36. Staff presented an overview of progress to date. The Committee will receive another update at the June 2019 meeting.
