Status of Amendments under Formal Review
 Description: NMFS SERO staff will update the Committee on the status of amendments
 under review or recently submitted.
 Required Committee Action: None.

2. Review of Red Snapper 2020 Season (Attachment 1)

Description: Council staff will provide a general overview of available information provided by the states on how the 2020 red snapper recreational season unfolded and update the Committee on the various data collection and monitoring efforts during the 4-day season. In addition, staff will present preliminary data obtained through the MyFishCount program.

Required Committee Action: None.

3. Wreckfish ITQ Modernization (Amendment 48; Attachment 2)

Description: In September 2019, the Council reviewed the final version of the 2019 Wreckfish ITQ Review. They received a presentation that outlined work done since the June 2019 meeting and outlined the Conclusions and Recommendations from the review. The Council approved the review as written and directed staff to begin the develop a plan amendment in 2020 to modernize the Wreckfish ITQ Program and include actions that address all of the conclusions and recommendations from the Wreckfish ITQ Review that can be addressed through a plan amendment. The Committee will review an options paper based on the conclusions and recommendations prepared by staff. The Council also directed that the goals and objectives approved in the 2016-2020 Vision Blueprint for the Snapper Grouper Fishery be included in the amendment as the new goals and objectives of the FMP.

Required Committee Action: Provide direction to staff for the development of Amendment 48 based on the options paper. The Committee may recommend that Council direct staff take the Wreckfish ITQ Modernization amendment out for scoping prior to the December 2020 meeting.

4. Red Porgy (Amendment 50; Attachment 3)

Description: At the June 2020 meeting, the Council directed staff to begin work on an amendment to end overfishing of red porgy, revise the rebuilding schedule, and address modifications to sector allocations and management measures. Staff will present an overview of the options paper and request guidance from the Committee on possible actions and the range of alternatives that should be developed to meet the Council's management objectives.

Required Committee Action: Discuss and provide guidance to staff

5. Topics for November 2020 Snapper Grouper Advisory Panel Meeting

Description: The Snapper Grouper Advisory Panel (AP) was scheduled to meet in April 15-16, 2020 to discuss the topics in the table below. However, the webinar meeting was postponed out of concern for the immediate impacts that the COVID-19 pandemic had on fishermen. The AP is scheduled to meet via webinar on November 4-6, 2020.
