SUMMARY REPORT FROM THE SNAPPER GROUPER COMMITTEE MEETING New Bern, NC December 7-8, 2010

The Snapper Grouper Committee met on December 7 & 8, 2010 in New Bern, NC. The Committee received a report from a representative of the Snapper Grouper Advisory Panel on their November 2010 meeting. The Committee also received a report from staff on *Oculina* research activities. The Committee discussed changes to the Comprehensive Annual Catch Limit Amendment and approved it for public hearings. The Committee made the following motions and provided the following guidance pertaining to the Comprehensive ACL Amendment.
